

Rationale

Recommendations developed by Administration:

- Reviewed the intent and outcomes of REP and other public health measures
- Targeted engagement with partner organizations
- A GBA+ lens was applied
- Evaluated legal implications and risks
- Evaluated resources required to implement and support
- Consulted with colleagues in Calgary and our regional partners



Recommendation - REP Equivalent

Administration does not recommend implementing a restriction exemption equivalent bylaw in its own facilities or for private businesses in Edmonton.

• Justification:

- Proof of vaccination does not equate to an absence of COVID-19
- Measures difficult to define and quantify
- Lacks complementary public health measures previously in place
- Not supported by the business community or regional partners
- Resource intensive with significant challenges on enforcement

Additional Considerations:

- Perception of safety influencing consumer confidence
- Privacy impacts with collecting requested information
- Private business have the ability to create their own rules
- Costs: Up to \$520K per month for CRF REP Facilities and marketing /promotion; and significant costs to initiate technology

Recommendation - Active Symptom Screening

Administration does not recommend implementing a Bylaw requiring businesses within the City to participate in an active COVID-19 symptom screening program

- Implications if a bylaw was implemented:
 - Inconsistency with regional partners
 - Time required for notification and adoption by businesses
 - Added cost and administration for businesses.
 - Limited ability for bylaw officers to enforce
- Any business can actively or passively screen attendees for symptoms (using the Alberta Health daily checklist) without a bylaw



Implementation of REP and/or Active Symptom Screening

Implementation would essentially look like this:

- REP or active symptom screening at applicable businesses
- REP in City facilities
- Enforcement through front line staff and a complaints based system



Temporary Mandatory Face Covering Bylaw

- For the time being we recommend the City's face covering bylaw remain in place with no changes.
- This will create some inconsistency with Provincial regulations, starting February 14 for those who are 12 and under
