A non-cash fare increase of 2% per year for 2021 and 2022 has been included to address increased service delivery costs for Edmonton Transit.

Cash fare increases in each of 2019-2021 has been included, to more closely align to the anticpated maximum fare payable in the Regional SMART Fare fare collection system. Upon implementation of Smart Fare, the Monthly Passes would transition to maximum monthly costs, Daily Passes would transition to daily maximums and Cash Fares would be replaced by trip minimum and maximum prices. Books of tickets would no longer be available.
