

## Bylaw 19726

A Bylaw to amend:

Bylaw 5739, as amended, being the Edmonton North Area Structure Plan,  
Bylaw 6288, as amended, being the Pilot Sound Area Structure Plan,  
Bylaw 7361, as amended, being the Castle Downs Extension Area Structure Plan,  
Bylaw 7464, as amended, being the Palisades Area Structure Plan,  
Bylaw 11870, as amended, being the Ellerslie Area Structure Plan,

WHEREAS pursuant to the authority granted to it, City Council has passed bylaws to adopt Area Structure Plans; and

WHEREAS from time to time City Council may find it desirable to amend the bylaws adopting Area Structure Plans; and;

WHEREAS the Municipal Council of the City of Edmonton now deems it in the public interest to amend the Pilot Sound Area Structure Plan, and

NOW THEREFORE after due compliance with the relevant provisions of the Municipal Government Act RSA 2000, ch. M-26, as amended, the Municipal Council of the City of Edmonton duly assembled enacts as follows:

1. That Bylaw 5739, as amended, being the Edmonton North Area Structure Plan, is hereby amended by:
  - a) adding the following paragraph after the first paragraph in section 2.2: Neighbourhood Designation:

The Mayliewan Neighbourhood Structure Plan (Bylaw 6497), Ozerna Neighbourhood Structure Plan (Bylaw 6385), Lago Lindo Neighbourhood Structure Plan (Bylaw 5898), and Belle Rive Neighbourhood Structure Plan (Bylaw 6311) are repealed effective June 8, 2021. Any reference to text, tables, figures, schedules and maps associated with the Mayliewan Neighbourhood Structure Plan (Bylaw 6497), Ozerna Neighbourhood Structure Plan (Bylaw 6385), Lago Lindo Neighbourhood Structure Plan (Bylaw 5898), and Belle Rive Neighbourhood Structure Plan (Bylaw 6311) are no longer applicable as of June 8, 2021.

2. That Bylaw 6288, as amended, being the Pilot Sound Area Structure Plan, is hereby amended by:

a) adding the following paragraph after the fifth paragraph in Chapter Four: Development Concept, I. Introduction:

The Matt Berry Neighbourhood Structure Plan (Bylaw 8936) and the Brintnell Neighbourhood Structure Plan (Bylaw 12492) are repealed effective June 8, 2021. Any reference to text, tables, figures, schedules and maps associated with the Matt Berry Neighbourhood Structure Plan (Bylaw 8936) and the Brintnell Neighbourhood Structure Plan (Bylaw 12492) within this Area Structure Plan are no longer applicable as of June 8 2021.

3. That Bylaw 7361, as amended, being the Castle Downs Extension Area Structure Plan, is hereby amended by:

a) adding the following paragraph after the first paragraph in section 4.4: Development Concept:

The Chambery Neighbourhood Structure Plan (Bylaw 7962) and the Elsinore Neighbourhood Structure Plan (Bylaw 7961) are repealed effective June 8, 2021. Any reference to text, tables, figures, schedules and maps associated with the Chambery Neighbourhood Structure Plan (Bylaw 7962) and the Elsinore Neighbourhood Structure Plan (Bylaw 7961) within this Area Structure Plan are no longer applicable as of June 8, 2021.

4. That Bylaw 7464, as amended, being the Palisades Area Structure Plan, is hereby amended by:

a) adding the following paragraph after the second paragraph in Section V: The Development Concept, I. Introduction:

The Cumberland Neighbourhood Structure Plan (Bylaw 7563) and the Oxford Neighbourhood Structure Plan (Bylaw 7963) are repealed effective June 8, 2021. Any reference to text, tables, figures, schedules and maps associated with the Cumberland Neighbourhood Structure Plan (Bylaw 7563) and the Oxford Neighbourhood Structure Plan (Bylaw 7963) within this Area Structure Plan are no longer applicable as of June 8, 2021.

5. That Bylaw 11870, as amended, being the Ellerslie Area Structure Plan, is hereby amended by:


a) adding the following paragraph after the first paragraph in section 5: Development Concept:

The Summerside Neighbourhood Structure Plan (Bylaw 12112) is repealed effective June 8, 2021. Any reference to text, tables, figures, schedules and maps associated with the

Summerside Neighbourhood Structure Plan (Bylaw 12112) within this Area Structure Plan are no longer applicable as of June 8, 2021.
