

Anti-Racism Advisory Committee:

- In April I made the following motion:
 - That Administration work with the Anti-Racism Advisory Committee to review and recommend changes to the anti-bullying provisions (8.1 and 8.2) in Bylaw 14614, Public Places Bylaw:
 1. To include in its offences any acts of harassment based on race, religion, sexual orientation or gender identity;
 2. To use restorative justice practices in response to any of these offences.
- Attended most meetings and offered advice carefully, as the members are growing into their roles. Their lived experience is critical to the success of ARAC.
- But I do think a council advisor would still be helpful in future.

Edmonton Historical Board:

- Facilitated connection between the Edmonton Historical Board and Boyle Street Community Services to recognize their 50th anniversary at their current location.
 - Exploring opportunities to rename the street
 - Recognized Boyle Street Services through council protocol in May
- Followed discussions regarding the Ring Houses at the University of Alberta and advocated for opportunities that would prevent demolition.
- North Saskatchewan Heritage River discussion came to the historical board and then on to council for discussion and vote.
- Discussions ongoing regarding the Wellington Bridge redevelopment in Glenora and the loss of built heritage. Administration continues to work with stakeholders, including the Old Glenora Conservation Association.
- Promoted the Edmonton Historical Board and the Centre for Race and Culture's virtual event "Renaming and Removal: Public Memory in Public Spaces."

Inter-City Forum on Social Policy:

- Updated the housing subcommittee on Edmonton's work on affordable housing, including the five modular supportive housing projects set to open in 2022, albeit without provincial support.
- At a subsequent subcommittee meeting, revealed the council-approved motion around the opioid overdose crisis and how harm reduction in supportive housing

is merited. Showed how the motion again seeks provincial financing and support for harm reduction inside housing with medical supervision.

- (Note: tremendous amount of empathy and support for Edmonton's work on housing the homeless and dealing with overdoses. Clearly, this is a province-wide issue and at least one other city is being encouraged to join Edmonton in its efforts).

REACH Edmonton Council for Safe Communities:

- REACH did considerable work over the past year on strategic planning and a review of its mandate. I encouraged ongoing measurement and focus on outcomes from its various programs.
- Sadly, Pilar Martinez timed out from the board. Pilar chaired REACH the last two years and she will be missed. But a number of new board members were just established on the board and it is a diverse, talented group.
- My office encouraged REACH to engage with Chinatown ... and, no surprise, REACH jumped at the opportunity and is hosting regular meetings on new ways to increase public safety in Edmonton's best dining area. :)
