

Edmonton Emergency Shelter Services


- The Government of Alberta funds and regulates emergency shelter operations
- There is capacity in Edmonton emergency shelters
- Many shelters are temporary in nature
- 650+ individuals sleep outside on any given night





Approach to Developing the Standard





- Review of evidence based best practices from other jurisdictions
- Stakeholder engagement: consideration of concerns and opportunities
- Review of regulatory options



What We Heard

30+ engagement sessions between April - July 2021

- Stakeholders included: people with lived experience, shelter operators, service providers, Indigenous organizations, Government of Alberta, AHS, Community Leagues, BIA's.

Key Themes

- Broad philosophical support for standards
- Urgent need for supportive housing
- Ongoing need for integrated mental health / clinical supports
- Indigenous services/operations to address historic trauma
- Shift to 24/7 operations, higher staff:guest ratios, smaller shelter sizes, improved training
- Good Neighbour Plans
- Data sharing and evaluation of collective outcomes

Requirements	Current: Government of Alberta Shelter Expectations		Proposed: City of Edmonton Minimum Emergency Shelter Standards
Food Service	Must comply with AHS Procedures.	+	Flexible food options available any time of day.
Sleeping Accommodations	Determined by shelter operator.	+	Beds off the ground 2 metres apart if in congregate setting, private or semi-private accomodations preferred.
Operating Hours	Determined by shelter operator.	+	24/7 admission to shelter; separate spaces for sleeping, programming, and meals.
Programs & Supports	Determined by shelter operator.	+	Four program areas that prioritize housing support, mental health and addictions support, and the needs of Indigienous people, LGBTQ2S+, and youth.
Good Neighbor Commitment	At discretion of shelter operator.	+	Operational requirement.
Evaluation	No standardized measurements of success.	+	Includes three sets of outcomes to evaluate accessibility and housing outcomes for guests.

Regulatory Options

- 1) Regulation through Business Licensing
- 2) Issuing Permits to Emergency Shelters

Limitations

- City lacks the authority to mandate entirety of the Standard
- Additional enforcement resources may be required to regulate shelters through either option
- Without additional resources and tools, shelters may be unable to meet licensing or permit requirements



Next Steps

- → Engage with shelter operators, Homeward Trust and other stakeholders on the development of educational tools that can assist in adopting the City of Edmonton Standard
- → Advocate to the Government of Alberta to adopt the City of Edmonton Standard and regulate requirements through formal funding agreements
- Encourage voluntary compliance from shelter operators through public communications strategy
