

Charter Bylaw 18523
A Bylaw to amend Bylaw 12800, as amended,
The Edmonton Zoning Bylaw
Amendment No. 2343

WHEREAS City Council at its meeting of February 22, 2001, gave third reading to Bylaw 12800, as amended; and

WHEREAS Council considers it desirable to amend the text of the Edmonton Zoning Bylaw;

NOW THEREFORE after due compliance with the relevant provisions of the Municipal Government Act RSA 2000, ch. M-26, as amended, the Municipal Council of the City of Edmonton duly assembled enacts as follows:

Bylaw 12800, as amended, The Edmonton Zoning Bylaw is hereby further amended by:

- a) adding the new section "Section 2.4 Cannabis Retail Sales" to "999.4 (MRC) Marquis Retail Centre Zone" , forming part of this bylaw and renumber accordingly and in alphabetical order;
- b) adding the new section Section 3 (l) – "Cannabis Retail Sales shall comply with Section 70 of this Bylaw" to "999.4 (MRC) Marquis Retail Centre Zone" , forming part of this bylaw;
- c) adding the new section "Section 2.4 Cannabis Retail Sales" to "999.5 (MMUT) Marquis Mixed Use Transition Zone" , forming part of this bylaw and renumber accordingly and in alphabetical order;
- d) adding the new section Section 4.19 – "Cannabis Retail Sales shall comply with Section 70 of this Bylaw" " to "999.5 (MMUT) Marquis Mixed Use Transition Zone" , forming part of this bylaw;
- e) adding the new section "Section 2.5 Cannabis Retail Sales" to "999.6 (MMS) Marquis Main Street Zone" , forming part of this bylaw and renumber accordingly and in alphabetical order;

- f) adding the new section Section 4.21 – “Cannabis Retail Sales shall comply with Section 70 of this Bylaw” to “999.6 (MMS) Marquis Main Street Zone” , forming part of this bylaw;
- g) adding the new section “Section 2.3 Cannabis Retail Sales” to “999.7 (MED) Marquis Entertainment District” , forming part of this bylaw and renumber accordingly and in alphabetical order; and
- h) adding the new section Section 4.9 – “Cannabis Retail Sales shall comply with Section 70 of this Bylaw” to “999.7 (MED) Marquis Entertainment District” , forming part of this bylaw.
