## Bylaw 19866

A Bylaw to amend Bylaw 9809, as amended, being the

## Aurum Industrial Business Park Area Structure Plan,

WHEREAS pursuant to the authority granted to it by the Municipal Government Act, on October 8, 1991, the Municipal Council of the City of Edmonton passed Bylaw 9809, being Aurum Industrial Business Park Area Structure Plan; and

Council found it desirable to amend the Aurum Industrial Business Park Area Structure Plan through the passage of Bylaws 15108, 18131, and 19453; and

WHEREAS an application was received by Administration to amend the Aurum Industrial Business Park Area Structure Plan; and

WHEREAS Council considers it desirable to amend the Aurum Industrial Business Park Area Structure Plan; and

NOW THEREFORE after due compliance with the relevant provisions of the Municipal Government Act RSA 2000, ch. M-26, as amended, the Municipal Council of the City of Edmonton duly assembled enacts as follows:


- 1. Bylaw 9809, Aurum Industrial Business Park Area Structure Plan, is hereby further amended as follows:

- c) Delete the map entitled "Figure 5 Development Concept" and replace it with the map entitled "Figure 5 Development Concept," attached hereto as Schedule "C" and forming part of this Bylaw.
