# **Northlands Agreement - Amendment**

#### Recommendation

That the amending agreement, as presented in Attachment 2 of the July 10, 2018, Urban Form and Corporate Strategic Development report CR\_6024, be approved.

#### **Previous Council/Committee Action**

At the September 11/12, 2017, City Council meeting, the following motion was passed:

That Administration negotiate with Edmonton Northlands, agreements as required to effect the transition of the operation of the Northlands site as outlined in the Memorandum of Understanding, as set out in Attachment 1 of the September 12, 2017, Financial and Corporate Services report CR\_5148.

At the December 5, 2017, City Council meeting, the following motion was passed:

1. That the agreements, as presented in Attachments 1 through 7 of the Financial and Corporate Services report CR\_5256, be approved and that approval of the attached agreements shall include the approval of such corrective, conformance and incidental amendments to such agreements as necessary or desirable to give effect to or implement the contemplated transaction, all as may be subsequently approved by the City Manager.

### **Executive Summary**

In alignment with Council's direction provided December 5, 2017, Administration continues to work with Northlands to effect the transition of Northlands Park and adjacent land south of the Expo Centre to the City's ownership. On May 1, 2018, Horse Racing Alberta and Edmonton Northlands agreed to extend the Northlands Race Track License from June 30, 2018 to January 31, 2019. The attached amending agreement for Council's approval extends the final date on which Edmonton Northlands must surrender the race track portion of the Northlands site to March 31, 2019.

## Report

Further to the meeting of City Council on December 5, 2017, Administration is working collaboratively with Edmonton Northlands for the orderly transition of the site. During this transition period, the City became aware of Horse Racing Alberta's desire to extend the Northlands Race Track License to January 31, 2019. Administration has

prepared the amending agreement (Attachment 2) for an extension to the ultimate date for final surrender by Edmonton Northlands of the Northlands site, including the horse racing facility, for Council's approval. All other conditions under the December 5, 2017 Staged Surrender agreement would remain in force.

## **Budget/Financial**

There are no anticipated cost implications in 2018 with this revised closure date.
