Bylaw 18398

Access closure to titled parcel at 10575 - 116 STREET NW

WHEREAS the Municipal Council of the City of Edmonton may pass a Bylaw pursuant to Section 28 of the *Highways Development and Protection Act*, S.A. 2004, c. H-8.5 for the purpose of removing any direct physical means of access between a controlled street and land adjacent to the controlled street; and

WHEREAS City Council has considered the proposed closing and has agreed that it is in the public interest to pass this Bylaw;

NOW THEREFORE the Municipal Council of the City of Edmonton, duly assembled, enacts as follows:

1. All means of access to or from a controlled street generally as shown on Schedule "A" is hereby closed.

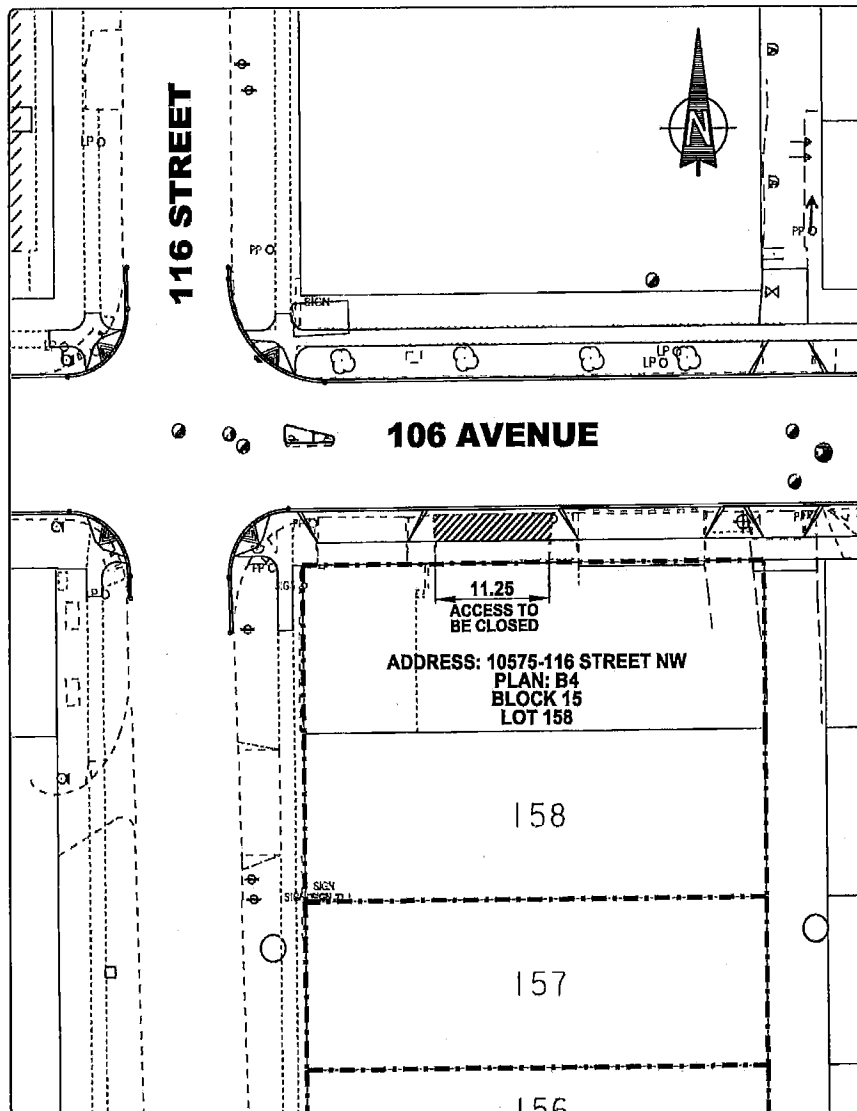
