BYLAW 19877
GENERAL REPEALING BYLAW - FALL 2021

Edmonton City Council enacts:

1. Bylaw 10240, A Bylaw to Approve Renewal of an Agreement with the Government of Canada for the Installation of an Outdoor Microphone and Pole on Canadian Forces Griesbach, is repealed.
2. Bylaw 8643, A Bylaw to Authorize an Agreement with the Government of Canada for the Municipal Infrastructure Evaluation at the C.F.B. Edmonton - Griesbach Site, is repealed.
3. Bylaw 8224, A Bylaw to Approve an Agreement with the Government of Canada for the Installation of an Outdoor Microphone and Pole on Canadian Forces Griesbach, is repealed.
4. Bylaw 7918, A Bylaw to Authorize Two Easement Agreements with Alberta Government Telephones for the Construction, Maintenance, Operation and Removal of a Freestanding Business Identification Sign at McCauley Plaza, 10025 - Jasper Avenue, Edmonton, is repealed.
5. Bylaw 7721, A Bylaw to authorize an agreement with the Province of Alberta to cover the cost of leasing the land from Canadian National Railways for the Access Road to Alberta Terminals Grain Elevator, is repealed.
6. Bylaw 1995, A Bylaw to authorize a temporary crossing by a single track of the Canadian National Railway over 149th Street between 115th and 116th Avenues in the City of Edmonton, is repealed.
7. Bylaw 254 1910, A By-law to authorize the transfer of certain lands to the Grand Trunk Pacific Railway Company, is repealed.
8. Bylaw 214 1901, A By-Law authorizing the execution of certain agreements respecting the Edmonton Yukon & Pacific Railways, is repealed.
9. Bylaw 237 1909, A Bylaw to approve and authorize the execution of an agreement respecting the entrance of the Calgary and Edmonton Railway into the City of Edmonton, is repealed.

10. Bylaw 7470, A Bylaw to authorize the agreements with the Government of Canada for lease of land at the Edmonton Municipal Airport, is repealed.
11. Bylaw 17400, Vehicle for Hire Bylaw, section 16(2)(a) is amended by deleting and replacing “of” with “or”.
12. Bylaw 19725, City Planning Framework Implementation Repealing Bylaw 2021, is revised by sections 12-14 of this bylaw.
13. The title of Bylaw 19725, City Planning Framework Implementation Repealing Bylaw 2021, is deleted and replaced with “Revised Bylaw 19725, City Planning Framework Implementation Repealing Bylaw 2021”.
14. Bylaw 19725, Schedule A, line 35 is revised by deleting and replacing “1116” with “11116”.
15. Bylaw 19852, Heritage Valley Town Centre Neighbourhood Area Structure Plan, is revised by sections 15-17 of this bylaw.
16. The title of Bylaw 19852, Heritage Valley Town Centre Neighbourhood Area Structure Plan, is deleted and replaced with “Revised Bylaw 19852, Heritage Valley Town Centre Neighbourhood Area Structure Plan”.
17. Bylaw 19852, Schedule A is revised by deleting and replacing “Amendment to Bylaw 19333 Heritage Valley Town Centre” with “Bylaw 19852 Amendment to Heritage Valley Town Centre”.
