Bylaw 18291 - Road Closure Application, Killarney

Closure of a portion of road right-of-way, 97 Street NW, north of 128 Avenue NW

Purpose

To close a portion of 97 Street NW road right-of-way; located north of 128 Avenue NW, Killarney.

Readings

This Bylaw is ready for three readings.

If Council wishes to give three readings during a single meeting, then prior to moving third reading, Council must unanimously agree "That Bylaw 18291 be considered for third reading."

Advertising and Signing

This Bylaw was advertised in the Edmonton Journal on Friday, March 16, 2018, and Saturday, March 24, 2018. The Bylaw can be signed and thereby passed following third reading.

Previous Council/Committee Action

At the April 3, 2018, Urban Planning Committee meeting, Bylaw 18291 was forwarded to City Council for the appropriate readings.

Position of Administration

Administration supports this Bylaw.

Report Summary

Bylaw 18291 proposes to close a portion of 97 Street for the purpose of being sold and consolidated with abutting land. This road closure allows for the activation of the freestanding sign that currently projects into the subject portion of 97 Street NW.

Report

The purpose of this application is to close a portion of 97 Street NW road right-of-way, located in the Killarney neighbourhood. Currently, the proposed closure area is being utilized as a parking area with a deactivated freestanding digital sign projecting into the subject road right-of-way. The proposed road closure will allow for the activation of the freestanding sign. The purpose of the application is to consolidate the proposed closure area with the property to the east (12831 – 97 Street NW). The parking area use will not be affected by the closure.

The proposed closure areas have been deemed surplus to City needs and do not affect the existing roadway's functionality. There are no outstanding technical concerns or requirements, and all comments from affected City Departments and utility agencies have been addressed.
