Bylaw 18246

Closure of a portion of road right-of-way along 124 Street NW, between 124 Avenue NW and 123 Avenue NW, Prince Charles

Recommendation:

That Urban Planning Committee recommend to City Council:

That Bylaw 18246 be given the appropriate readings.

Purpose

To permanently close a portion of 124 Street, between 124 Avenue NW and 123 Avenue NW, to vehicular traffic, according to the approved recommendations from the Prince Charles Community Traffic Management Pilot Project.

Readings

Bylaw 18246 is ready for three readings.

This Bylaw is authorized under Section 22 of the *Municipal Government Act*. A majority vote of City Council on all three readings is required for passage.

If Council wishes to give three readings during a single meeting, then prior to moving third reading, Council must unanimously agree "That Bylaw 18246 be considered for third reading."

Advertising and Signing

This Bylaw was advertised in the Edmonton Journal on Friday, March 16, 2018, and Saturday, March 24, 2018. Bylaw 18246 can be signed and thereby passed following third reading.

Position of Administration

Administration supports this Bylaw.

Report Summary

This report requests City Council's approval of Bylaw 18246.

Report

In July 2015, a trial traffic management plan was installed in the Prince Charles neighbourhood to address issues of traffic shortcutting and speeding. Part of the trial included closing a portion of road right-of-way along 124 Street NW, between 124 Avenue NW and 123 Avenue NW, to remove the shortcut route between 118 Avenue and Yellowhead Trail. The trial was evaluated over the course of one year.

On April 11, 2017, members from the Prince Charles Community Traffic Management Plan Pilot Project presented Council with the results of the trial, including the road closure. For collector roadways similar to 124 Street, traffic volumes are typically lower than 5,000 vehicler per day. At Prince Charles Park, which is in the "middle" of the corridor, data showed the traffic past the park was reduced from 6,800 vehicles per day to 2,100 vehicles per day during the trial. Recognizing the traffic plan had addressed community concerns with traffic shortcutting and was generally supported by neighbourhood residents, City Council approved the report's recommendation to make the closure permanent.

This Bylaw (Attachment 1) is the next required step to make the road closure permanent.

Legal Implications

- The proposed road closure must be carried out in accordance with the *Municipal Government Act*.
- Section 22 of the *Municipal Government Act* provides that City Council may close a road by passing a bylaw.
- Section 23 of the *Municipal Government Act* provides that any person who occupies, owns or has an interest in land that sustains damages through the closing of a road by bylaw must be compensated for the damages. Any unresolved claims are to be determined by the Land Compensation Board.

Justification of Recommendation:

Approving the Bylaw supports the City's aim to build safe and healthy communities. It also supports Vision Zero.
