Attachment 1

The federal Cannabis Act proposes the following restrictions related to cannabis legalization:

- Possession will be permitted to individuals 18 years of age or older (maximum 30 grams).
- Limits for the number of plants per household is four.
- Prohibits the sale of cannabis and cannabis accessories that are packaged and labelled in a manner that is appealing to youth, including elements intended to encourage consumption, such as lifestyle branding elements or testimonials.
- It is prohibited for a person that is authorized to sell cannabis to display it, or any package or label of cannabis, in a manner that may result in the cannabis, package or label being seen by a young person.
- Licence for standard cultivation would authorize the cultivation of any variety of cannabis and to produce cannabis seeds, cannabis plants, fresh cannabis and dried cannabis. A licence for standard cultivation would also authorize associated or supplemental activities related to these core activities, including possession, transportation, research and development, storage, and destruction.
- Licence for standard processing would authorize the production and packaging and labelling of a range of cannabis products destined for sale to the public. Authorized activities would include manufacturing cannabis oil (cannabis resin), synthesizing phytocannabinoids, the manufacturing of other authorized products (e.g., pre-filled cannabis oil capsules or oral sprays), and/or the packaging and labelling of products for sale to the public. A licence for standard processing would also authorize related activities, including possession, transportation, research and development, storage, destruction, and the intra-industry sale of cannabis to other federal licence holders or provincially- or territorially-authorized sellers.

The Government of Alberta has released the following specific regulations related to cannabis legalization:

- 100 metre buffer for cannabis stores from schools and provincial health-care facilities.
- Store hours set between 10:00 a.m. and 2:00 a.m..
- Adults will be able to grow up to four plants per household from seeds purchased from licensed cannabis retailers.
- Privately run cannabis stores will sell cannabis and accessories under strict regulations. The Alberta Gaming and Liquor Commission will be the exclusive online retailer and distributor in Alberta.
- Cannabis consumption will be
 - prohibited in any motor vehicles, with the exception of those being used as a temporary residences, such as a parked recreational vehicle. Penalties will be the same as alcohol impaired driving;
 - be allowed in private residences and in some public spaces where smoking tobacco is allowed;
 - prohibited at cannabis retail outlets;

- In an effort to protect children and limit second-hand exposure, public smoking or vaping of cannabis in Alberta will be prohibited from any place where tobacco is restricted, and in the following places:
 - on any hospital property, school property or child care facility property.
 - in or within a prescribed distance from a playground, a sports or playing field, a skateboard or bicycle park, a zoo, an outdoor theatre, an outdoor pool, or a splash pad.
