**REPORTING** 19.2 The City Manager must, at least once annually, provide a report to Committee that includes:

- (a) the value and nature of all Non-Audit Services approved and not approved by Committee pursuant to section 19.1(a) since the last report; and
- (b) the value and nature of each Non-Audit Service approved and not approved by the City Manager pursuant to section 19.1(b) since the last report.
- 12. Section 21 is deleted and replaced with:
  - The City Manager will provide an annual report to the Committee regarding the External Auditor's performance.
- 13. Section 28(b) is amended by deleting and replacing "by Council at its Inaugural Meeting, or so soon thereafter as Council may meet to make appointments to the Committee" with "pursuant to the Council Committees Bylaw".
- 14. Section 32.1 is deleted and replaced with:
