A Bylaw to amend Bylaw 11870, as amended, being the Ellerslie Area Structure Plan

WHEREAS pursuant to the authority granted to it by the Municipal Government Act, on January 5, 1999 the Municipal Council of the City of Edmonton passed Bylaw 11870, as amended, being the Ellerslie Area Structure Plan; and

WHEREAS Council found it desirable to amend Bylaw 11870, as amended, the Ellerslie Area Structure Plan through the passage of Bylaws 12111, 12581, 12609, 13450, 13535, 13665, 14012, 14146, 14266, 14508, 14518, 14583, 14723, 14693, 15067, 15345, 15713, 16446, 16593, 16668, 17085, 17654, 17714, 17802, and 17756; and

WHEREAS an application was received by City Planning to amend the Ellerslie Area Structure Plan; and

WHEREAS Council considers it desirable to amend the Ellerslie Area Structure Plan;

NOW THEREFORE after due compliance with the relevant provisions of the Municipal Government Act RSA 2000, ch. M-26, as amended, the Municipal Council of the City of Edmonton duly assembled enacts as follows:


1. That Bylaw 11870, as amended, the Ellerslie Area Structure Plan is hereby further amended by:

- f. deleting "Figure 10 Circulation System" and substituting it with "Figure 10 Circulation
 System", attached hereto as Schedule "F"; and forming part of this Bylaw; and
- g. deleting "Figure 11 –Neighbourhood & Staging Concept" and substituting it with "Figure 11 –Neighbourhood & Staging Concept", attached hereto as Schedule "G"; " and forming part of this Bylaw.








