

Bylaw 18260

A Bylaw to amend Bylaw 6616, as amended,
Being the Terra Losa Neighbourhood Area Structure Plan

WHEREAS pursuant to the provision of the Planning Act, City Council on May 11, 1982 passed Bylaw 6616, as amended, being the Terra Losa Neighbourhood Area Structure Plan; and

WHEREAS Council found it desirable to amend the Terra Losa Neighbourhood Area Structure Plan through the through the passage of Bylaws 7173, 7265, 7526, 10949, 11532, 12200 and 12828; and

WHEREAS an application was received by City Planning to further amend the Terra Losa Neighbourhood Area Structure Plan; and

WHEREAS Council considers it desirable to further amend the Terra Losa Neighbourhood Area Structure Plan;

NOW THEREFORE after due compliance with the relevant provisions of the Municipal Government Act, S.A. 1994, c. M-26.1, as amended, the Municipal Council of the City of Edmonton duly assembled enacts as follows:

1. Bylaw 6616, as amended, is hereby amended by:
 - a) deleting therefrom the statistics entitled "Terra Losa Neighbourhood Area Structure Plan – Land Use and Population Statistics - Bylaw 12828" and substituting therefor new statistics entitled "Terra Losa Neighbourhood Area Structure Plan – Land Use and Population

Statistics - Bylaw 18260" and forming part of this Bylaw; and




