## Bylaw 20155

## A Bylaw to amend Bylaw 5739, as amended, being the Edmonton North Area Structure Plan

WHEREAS pursuant to the authority granted to it by the <u>Planning Act</u>, on August 15, 1979, the Municipal Council of the City of Edmonton passed Bylaw 5739, being the Edmonton North Area Structure Plan; and

WHEREAS Council has from time to time amended Bylaw 5739, the Edmonton North Area Structure Plan, through the passage of Bylaws 6253, as amended, 7311, 7362, 10683, 11541, 12950, 13058, 13887, 14442, 14492, 14608, 14624, 14598, 14719, 15054, 15226, 15315, 15425, 15548, 18629, 19260, and 19726; and

WHEREAS an application was received by Administration to amend Bylaw 5739, as amended, the Edmonton North Area Structure Plan, and

WHEREAS Council considers it desirable to amend Bylaw 5739, as amended, the Edmonton North Area Structure Plan;

NOW THEREFORE after due compliance with the relevant provisions of the Municipal Government Act RSA 2000, ch. M-26, as amended, the Municipal Council of the City of Edmonton duly assembled enacts as follows:

- 1. Bylaw 5739, as amended, the Edmonton North Area Structure Plan is hereby amended by:
  - a. deleting the map entitled "Bylaw 19260 Edmonton North Area Structure Plan" and substituting therefore the map entitled "Bylaw 20155 Amendment to Edmonton North Area Structure Plan" attached hereto as Schedule "A" and forming part of this Bylaw; and
  - b. deleting the statistics entitled "Edmonton North Area Structure Plan Land Use and Population Statistics Bylaw 19260" and replacing it with "Edmonton North Area Structure Plan Land Use and Population Statistics Bylaw 20155", attached hereto as Schedule "B" and forming part of this Bylaw.


