**COUNCIL PROCEDURES BYLAW AND COUNCIL COMMITTEES BYLAW**  
**AMENDMENTS**

Edmonton City Council enacts:

1. Bylaw 18155, Council Procedures Bylaw, is amended by sections 2-7 of this bylaw.
2. Section 14.1(4)(b) is deleted.
3. Section 21(3) is added following section 21(2):
  - (3) This section does not apply to Agenda Review Committee, as defined in the Council Committees Bylaw, Bylaw 18156.
4. Section 23 is renumbered as section 23(1).
5. Section 23(1) is amended by inserting “regular” before “Council or Standing Committee”.
6. Section 23(2) is added following section 23(1):
  - (2) Subsection (1) does not apply to Agenda Review Committee or any sub-committee of a Standing Committee created pursuant to this or any other bylaw.
7. Section 24(e) is amended by deleting and replacing “48 hours” with “two business days”.
8. Bylaw 18156, Council Committees Bylaw, is amended by sections 9-18 of this bylaw.
9. Section 11(e) is amended by deleting “after receiving approval from the Council Committee.”
10. Section 18(a) is amended by inserting “and re-routing reports” after “long-term agenda planning”.
11. Section 18(i) is amended by inserting “and rate filing” after “rates”.

12. Section 20(1) is amended by deleting and replacing “City agencies, boards, and commissions” with “agencies, boards, and commissions”.
13. Section 20(2) is amended by deleting and replacing “City agencies, boards, and commissions” with “agencies, boards, and commissions”.
14. Section 21(1) is deleted and replaced with:

**MEMBERSHIP**

- 21 (1) The members of Agenda Review Committee are:
- (a) if the agenda for the meeting only contains items that are scheduled to be discussed at Council, the Mayor; or
  - (b) if the agenda for the meeting contains items that are scheduled to be discussed at Council or a Standing Committee, the Mayor and the Chair of each affected Standing Committee.

15. Section 21(2) is deleted.
16. Section 22(1) is amended by deleting “The”.
17. Section 22(3) is amended by deleting “The”.
18. Section 25.1 is added following section 25:

**CODE OF CONDUCT  
SUB-COMMITTEE**

- 25.1 (1) A temporary sub-committee of Council Services Committee, named the Code of Conduct Sub-Committee, is established.
- (2) The mandate of the Code of Conduct Sub-Committee is to:
- (a) review the Council Code of Conduct Bylaw, Bylaw 18483, and provide recommendations for changes; and
  - (b) any other matters referred to it by Council.

**MEMBERSHIP**

- (3) Immediately following the coming into force of this section, Council must appoint four Councillors to form the membership of the Code of Conduct Sub-Committee for the remainder of their term of office, or until this section is repealed, whichever is earlier.

**PROCEDURES**

- (4) The Code of Conduct Sub-Committee will follow all procedures prescribed by this and the Council Procedures Bylaw as if it were designated as a Standing Committee.
