### HOW DOES THE CITY CALCULATE MY PROPERTY TAX?

The calculation of your share of municipal property taxes is based on the amount the City of Edmonton requires to continue offering municipal programs and

To see the formula the City uses to calculate your property taxes, sign up for our secure site for property owners at myproperty.edmonton.ca.

#### WHERE DO MY TAX DOLLARS GO?

Your property tax bill consists of municipal and provincial education taxes, but may also include local improvement charges and special taxes.

Municipal taxes are set by the City of Edmonton and are one of the revenue sources the City uses to fund services like police and fire protection, road maintenance and snow clearing, parks and swimming pools, public transit and neighbourhood infrastructure.

Provincial education taxes are set by the Government of Alberta. The City of Edmonton collects these taxes and sends them directly to the provincial government.

#### **HOW DO I REQUEST A PAYMENT RECEIPT?**

After you make a payment, please visit myproperty.edmonton.ca to review the transaction history or tax account balance reports as a confirmation of payment.

#### IS THERE ANY ASSISTANCE FOR SENIORS?

The Government of Alberta offers the Seniors Property Tax Deferral program for senior homeowners. For more information, contact the Government of Alberta directly at 780-644-9992.

#### WHAT IF I DON'T PAY?

We encourage you to resolve any questions you have about your taxes well in advance of the due date. If the City does not receive full payment on time, you will be subject to the following penalties:

- 5% on July 1, 5% on September 1 and 5% on November 2—on the outstanding balance of current year taxes.
- 1.25% each month starting January 1—on the outstanding balance of prior years' taxes.
- 1.25% per month—on additional charges, including supplementary taxes, following the due date.

### MONTHLY

Take advantage of the City's property tax monthly payment plan. Enrolling in this plan allows you to pay your property taxes in monthly instalments by automatic bank withdrawal

You can sign up for this program at any time, but it is best to do so by November 30 for the upcoming tax year to avoid paying an administration fee-2% of the initial payment amount.
