

## **CITY OF EDMONTON**

### **BYLAW 20215**

Bylaw 20215 to amend Bylaw 16846, as amended by Bylaws 17100, 19241 and 20049, to authorize the City of Edmonton to undertake, construct and finance The City of Edmonton Capital City Downtown Community Revitalization Levy Area Projects

#### **WHEREAS:**

- A. The Council of the City of Edmonton on July 16, 2014 duly passed Bylaw 16846, as amended by Bylaw 17100 duly passed on April 14, 2015, as amended by Bylaw 19241 duly passed on June 22, 2020, as amended by Bylaw 20049 duly passed on May 9, 2022, authorizing the City of Edmonton to undertake, construct and finance The City of Edmonton Capital City Downtown Community Revitalization Levy Area Projects (“Projects”), and also authorizing the Mayor and Chief Administrative Officer to borrow the sum of \$101,506,000.00 for a period of twenty (20) years with the principal and interest to be repaid in semi-annual or annual instalments;
- B. The borrowing authority for the Projects will be increased by \$1,999,000.00 from \$101,506,000.00 to \$103,505,000.00. Furthermore, the total cost of the Projects is now \$111,222,000.00 as a result of previously approved adjustments.

THEREFORE, THE COUNCIL OF THE CITY OF EDMONTON DULY ASSEMBLED ENACTS AS FOLLOWS:

1. Bylaw 16846 is amended in the preamble, paragraph two, thereof by deleting the figure "\$109,223,000.00" as it appears and by substituting the figure "\$111,222,000.00".
2. The said Bylaw is further amended in the preamble, paragraph four, in Sections (1), (2) and (10), thereof by deleting the figure "\$101,506,000.00" as it appears and by substituting the figure "\$103,505,000.00".
3. The said Bylaw is further amended in the preamble, paragraph seven, thereof by deleting the date "December 31, 2020" and the amount of "\$3,407,145,492.13" for the existing debt of the City of Edmonton as it appears and substituting the date "December 31, 2021" and the figure "\$3,546,570,054.36".
4. The said Bylaw is further amended by replacing Schedule "A" with Schedule "A" as attached.

5. This Bylaw shall take effect on the day of the final passing thereof.
