A Bylaw to amend Bylaw 12800, as amended, The Edmonton Zoning Bylaw <u>Amendment No. 3448</u>

Appendix 1 of the North Saskatchewan River Valley and Ravine System Protection Overlay of the Edmonton Zoning Bylaw is hereby amended by adding those lands shown as changing to (A) Metropolitan Recreation Zone on the sketch plan attached as Schedule "A", such lands legally described as a portion of Lot 3ER, Block 1, Plan 0320993; located at 2150 - 111 Street SW, Cavanagh, Edmonton, Alberta, within the area of application of the North Saskatchewan River Valley and Ravine System Protection Overlay.
