Plan and Policy Alignment

In addition to those policies identified in the report, a number of other Plans and Policies support daylighting and restoration of Mill Creek, including:

The Way We Move, Transportation Master Plan:

- Strategic Goal: Sustainability. Transportation decisions reflect an integrated approach to environmental, financial and social impacts thereby creating sustainable, livable communities that minimize the need for new infrastructure and increase residents' quality of life.
- 6.1(e): Providing well-integrated transitions between sidewalks, the multi-use trail corridor network, other pedestrian networks, transit facilities, parkland, and the river valley and ravine systems.
- 6.3(a): Developing a coordinated network of multi-use trails throughout the city, including integration with Edmonton's river valley, parkland and utility corridors, as well as regional connections.
