The Financial Services Branch updated City Policy C217E Reserve Funds & Equity Accounts Policy with definitions and provisions that clarify the roles, responsibilities, and administration of the City's Reserve Funds. The policy has been updated to direct users to a Reserve Register that describes each reserve fund, specifically its purpose, permitted uses, and the responsible City Branch.

The Corporate Procurement and Supply Services Branch staff have developed and implemented a new Procurement Standard that addresses this recommendation among other changes. The Procurement Standard replaces Procurement Administrative Policy (A1465) and its related procedures. It consolidates 13 guiding documents into one comprehensive standard. The Procurement Standard provides clearer guidance on the use of invitational processes, in particular for non-competitive procurements.

The Parks and Roads Services Branch developed and implemented a change management framework and toolkit to support and improve change management processes. The toolkit includes a change management process workflow, interactive decision trees on change management plans, text case examples, templates and educational resources. The Parks and Roads Services Branch entered into a partnership agreement with Fleet and Facility Services Branch. The agreement will be reviewed annually. The agreement outlines roles and responsibilities for both branches, scope of key services provided by Fleet and Facility Services Branch, communication and reporting tactics, issue resolution process, KPI levels for equipment, and billing and payment terms.

The Parks and Roads Services Branch developed and implemented a staff oversight framework with linked resources and tools for the 2022-2023 winter season. The framework is designed to support consistent application and level of staff oversight among staff and teams, increased communication and provides opportunities for staff engagement and feedback year-round, and increased staff empowerment for operational decision-making.
