Bylaw 17890 To Designate the Prince of Wales Armoury as a Municipal Historic Resource Amendment No. 1

Purpose

To amend Bylaw 13465 to correct a typographical error in the legal description and address for the historic resource and to adopt the consolidated Bylaw 13465.

Readings

Bylaw 17890 is ready for three readings.

Bylaw 17890 is authorized under the Alberta *Historical Resources Act*. A majority vote of City Council on all three readings is required for passage.

If Council wishes to give three readings during a single meeting, then prior to moving third reading, Council must unanimously agree "That Bylaw 17890 be considered for third reading."

Advertising and Signing

This Bylaw is not required to be advertised and can be signed and thereby passed following third reading.

Position of Administration

Administration supports this Bylaw.

Report Summary

Bylaw 13465, being a Bylaw to Designate the Prince of Wales Armoury as a Municipal Historic Resource, is being amended to correct a typographical error in the legal description of the historic resource, to update Schedules "A" and "C" of the Bylaw and to adopt the consolidated Bylaw 13465 as the official version of Bylaw 13465.

Report

The property known as the Prince of Wales Armoury, located at 10440 – 108 Avenue NW, was designated by City Council as a Municipal Historic Resource by Bylaw 13465, on August 31, 2004.

Bylaw 13465 contains a typographical error in the legal description of the Prince of Wales Armoury, which prevents its registration at Alberta Land Titles.

Bylaw 17890 - To Designate the Prince of Wales Armoury as a Municipal Historic Resource Amendment No. 1

The Location Plan in Schedule "A" to the Bylaw, The Identification of the Regulated Portions of the Edmonton Drill Hall/Prince of Wales Armoury (Circa 1915), also requires updating to reflect the correct legal description of the property.

Schedule "C" to the Bylaw, the Rehabilitation Incentive and Maintenance Agreement, also requires updating to reflect the correct legal description of the property.

Correction of the typographical error in the legal description of the property and updating Schedules "A" and "C" of the Bylaw will permit the registration of Bylaw 13465 at Alberta Land Titles.

This Bylaw also incorporates the amendments set out in this Bylaw into Bylaw 13465, and adopts this consolidation as the official version of Bylaw 13465.

Policy

City Policy C450B – Policy to Encourage the Designation and Rehabilitation of Historic Resources in Edmonton

Corporate Outcomes

This report contributes to the corporate outcome "Edmonton is attractive and compact" as it completes the process to legally protect the Prince of Wales Armory. This represents an investment in a historical property within an existing neighbourhood, which plays a role in continually improving Edmonton. Designation sustains Edmonton's attractive built heritage, connecting Edmontonians with their past.

Legal Implications

In consideration for the incentive payable for rehabilitation of the resource (as described in Schedule C), the owner has waived the right to compensation under the Alberta *Historical Resources Act*.
