The governing documents of these corporations confirm that this budgeting power is reserved for the boards. The City cannot exert direct control over the budgets of most corporations, even if the City is the sole or partial owner (shareholder/member) of the corporation. Although a corporation's budget may be brought before the shareholder/member at an annual general meeting, it is still the Board of Directors that is responsible for actually approving the budget. In some cases, a City representative sits as a voting Director of a corporation. If so, they may cast their Director's vote in support of or against that corporation's budget, and attempt to convince other Directors to do the same. Where a City representative sits as an ex officio (non voting) Director of a corporation, they do not have the ability to cast a Director's vote regarding that corporation's budget.
