Mandate

The Naming Committee (NC) was established to name the City of Edmonton's development areas, parks, municipal facilities, honorary roads and wards, in accordance with and subject to any exemptions or restrictions imposed by City policy.

Activities (Annual Report) - Attachment 1

The 2022 Annual Report provides a summary of the NC's highlights and approvals for 2022. These include, approving:

- the naming of Kisêwâtisiwin ᑭᓴᓪᓴᑦᓴᓴᓴᓴ Park within the Alberta Avenue Neighbourhood;
- the honorary naming of the Pride Corner at 82 Avenue (Whyte Avenue) and 104 Street;
- the naming of Mistâpos ᓄᓴᓴᓴᓴ Park within the Prince Rupert Neighbourhood; and
- numerous road names, honorary road names, park and open space names and municipal facility names in Edmonton.

Annual Report and Work Plan Requirements

Annual Report and Work Plan requirements for the NC are outlined in:

- Bylaw 18156 - Council Committees Bylaw
 - Section 4(2): All Council Committees will report to Council at least annually.
 - Section 10:
 - At least annually, a Council Committee must approve a work plan that aligns with its mandate and identifies its anticipated resource requirements.
 - During its annual report to Council required by section 4(2), a Council Committee must present its work plan for the current year and summary of its most recently completed work plan.
- Council Policy and Procedure C575D - Agencies, Boards, Committees and Commissions
 - Section 5 specifies that City Agencies will annually report to a City Council meeting with:
 - activities;
 - annual work plan aligned to strategic objectives and mandate; and
 - budget information.
