### **Best Practices on Ending Unsheltered Homelessness**

In March 2022, Canadian Alliance to End Homelessness commissioned OrgCode Consulting Inc. to create a resource on ending homelessness for people living in encampments in Canada, with input from a large cross-section of stakeholders. Below are recommendations for a municipalities encampment response and how Edmonton's response aligns to them.

Appropriate and adequate housing

Increase interim accommodation options such as bridge housing	Partially Implemented •	The City of Edmonton has provided funding for bridge housing transition plans to Homeward Trust Foundation (\$4.8 million - Sandy's Place, Sands Inn, Coliseum Inn, Travelodge West), Jasper Place Wellness (\$7.5 million bridge housing and shelter project at 15540 Stony Plain Road NW) and to The Royal Alexandra Hospitals Foundation (\$290,000 - bridge housing centre at 160 and 100 Avenue).
Increase portable rental supplements (Rent supplements that are attached to the individual, couple or family - not a unit - to allow more access to private market housing where affordability is the barrier)	Not Started •	Typically addressed at provincial level. Environmental scanning has found examples of municipal rental supplement programs in Canada and the United States.
Increase supply of affordable and supportive housing	In Progress •	Under the Rapid Housing Initiative 1.0: Five new Supportive Housing sites opening in 2023 (210 units); Rapid Housing Initiative 2.0: Three supportive housing sites funded, with one site opened in 2022 and the two remaining scheduled for opening in 2023 (236 units); Rapid Housing Initiative 3.0 in progress (proposed 351 units).

The strategy work includes: summer mobile washroom program and washroom attendant program. The public washroom strategy also responds to the Shigella outbreak by providing laundry and shower services, drinking water and free menstrual products at portable washroom locations and permanent locations.
