

Provincial Wildfire Situation

- 105 wildfires burning
- Evacuation orders in place for 29,000 people
- Eleven states of local emergency, two Band Council resolutions of emergency

Provincial Declaration of Emergency

• A legal mechanism under the Emergency Management Act

- Declared by Cabinet
- In effect for 28 days
- Grants additional authorities

Emergency Management Act authorities

- Implement or require an emergency plan
- Acquire or use property to alleviate emergency
- Require people to render aid
- Control or prohibit travel
- Restore facilities, distribute supplies for essential services
- Order evacuations
- Enter buildings or land
- Demolish or remove trees
- Procure or fix prices
- Conscript people to provide services

 - Enforcement activity prioritized
- Actions to support regional partners
- Actions to support people who have been evacuated



Evacuation Centre Services

- Registration for individuals and pets
- Essential supplies clothing, bedding, toiletries
- Meals
- Lodging, if necessary
- Activities for children
- Temporary pet care
- Red Cross, AHS
- Insurance companies



Donations

Financial Cost Tracking

- Financial cost tracking will be necessary to recover costs through a Disaster Recovery Program (DRP)
- Financial processes in place early to ensure all costs for the City are tracked
