**BYLAW 20212**

Bylaw 20212 to amend Revised Bylaw 19781, to authorize the City of Edmonton to undertake, construct and finance Integrated Infrastructure Services Project, Capital Line, Century Park to 41 Avenue SW

**WHEREAS:**

- A. The Council of the City of Edmonton on August 16, 2021 duly passed Revised Bylaw 19781, authorizing the City of Edmonton to undertake, construct and finance Integrated Infrastructure Services Project, Capital Line, Century Park to 41 Avenue SW (“Project”), and also authorizing the Mayor and Chief Administrative Officer to borrow the sum of \$330,653,000.00 for a period of twenty-five (25) years with the principal and interest to be repaid in semi-annual or annual instalments;
- B. It has now been determined that the total cost of the Project is \$1,100,040,000.00. The borrowing authority will therefore be increased by \$12,000,000.00 from \$330,653,000.00 to \$342,653,000.00;

THEREFORE, THE COUNCIL OF THE CITY OF EDMONTON DULY ASSEMBLED ENACTS AS FOLLOWS:

1. Revised Bylaw 19781 is amended in the title and in the preamble, Sections (A), thereof by deleting the words “Capital Line, Century Park to 41 Avenue SW” as it appears and by substituting the words “Capital Line South LRT: Century Park to Ellerslie Road”.
2. The said Bylaw is further amended in the preamble, Section (B), thereof by deleting the figure “\$1,040,039,000.00” as it appears and by substituting the figure “\$1,100,040,000.00”.
3. The said Bylaw is further amended in the preamble, Section (D) and in Sections (1) and (2), thereof by deleting the figure “\$330,653,000.00” as it appears and by substituting the figure “\$342,653,000.00”.
4. The said Bylaw is further amended in the preamble, Section (G), thereof by deleting the date “December 31, 2020” and the amount of “\$3,407,145,492.13” for the existing debt of the City of Edmonton as it appears and substituting the date “December 31, 2021” and the figure “\$3,546,570,054.36”.
5. The said Bylaw is further amended by replacing Schedule “A” with Schedule “A” as attached.

6. This Bylaw shall take effect on the day of the final passing thereof.
