Executive Summary

- At the September 29, 2022, Code of Conduct Sub-Committee meeting, Administration presented Office of the City Manager report OCM00775, Council Code of Conduct - Lessons Learned, and the Integrity Commissioner and Ethics Advisor submitted a presentation, with recommended revisions to Bylaw 18483 - Council Code of Conduct.
- At the January 24, 2023, Code of Conduct Sub-Committee meeting, Administration presented the Office of the City Clerk report OCC01534, which included a work plan for reviewing Bylaw 18483 - Council Code of Conduct. The Sub-Committee provided feedback on potential changes to Whereas Clauses and Schedule A.
- At the March 3, 2023, Code of Conduct Sub-Committee meeting, the Sub-Committee completed the work plan.
