Executive Summary

- Each year, the City of Edmonton enters into a license agreement with the Edmonton Minor Hockey Association for the purpose of providing minor hockey ice time in City of Edmonton arenas.
- As per Bylaw 16620 City Administration Bylaw, license agreements with a value over \$1,000,000 require approval by the appropriate standing committee of City Council.
- The Edmonton Minor Hockey Association's initial booking request for the 2023/2024 winter ice season license agreement is for a maximum amount of \$4.67 million, therefore, must be approved by Committee.

REPORT

The Edmonton Minor Hockey Association takes part in the City's annual arena allocation process. Arena allocation is conducted by the City's Arena Users Committee. The Committee is composed of members of Administration and individuals representing the various sports and organizations that take place in arenas. The allocation process allows for fair and equitable distribution of arena time to Edmonton-based groups and organizations providing sport and recreation opportunities in City-owned arenas.

The Edmonton Minor Hockey Association's initial booking request for the 2023/2024 winter season is for approximately 26,784 hours of rental time and a total amount payable to the City of approximately \$4.67 million, as outlined in Attachment 1. Continual adjustments are made to the rental time slots up until the start of the 2023/2024 winter season as the Edmonton Minor Hockey Association refines its schedule, with further adjustments permitted prior to the playoffs beginning in March 2024.

Budget/Financial Implications

The total amount due to the City as well as the corresponding installments as set out in the license agreement will be updated to reflect the actual amount owed. The annual license agreement with the Edmonton Minor Hockey Association complies with City Council approved fees and charges.

The Edmonton Minor Hockey Association's actual bookings for the 2022/2023 winter season were for 24,087.75 hours of rental time, totalling \$4.1 million, including goods and services tax.

COMMUNITY INSIGHT

Administration works closely with the Edmonton Minor Hockey Association to generate the license agreement. The Edmonton Minor Hockey Association has representation on the City's Arena Users Advisory Committee. The amount of time requested by the Edmonton Minor Hockey

Association is in accordance with the approved standards of play for hockey, set by the City of Edmonton Arena Advisory Committee in accordance with Hockey Alberta and Hockey Canada.

GBA+

- The Edmonton Minor Hockey Association is one of many Edmonton-based, not-for-profit youth organizations that are allocated time in City of Edmonton arenas. Each organization receives an equitable share of time based on the number of participants and the amount of time required to facilitate programming. If the overall supply of arena time is less than demand, each organization's allocated time is reduced by the same percentage so that supply equals demand.
- Arena fees are Council approved and a reduced rate is provided for Edmonton-based not-for-profit youth organizations.
- Edmontonians register directly with the Edmonton Minor Hockey Association to participate in programs. The Edmonton Minor Hockey Association places a high priority on diversity and inclusion, offering programs for all youth regardless of their gender and abilities. This organization has support mechanisms in place and works with partner organizations such as KidSport and Sport Central to assist families facing financial hardships to ensure that everyone has the opportunity to play hockey.
