### **BYLAW 20581 - FALL 2023 GENERAL REPEALING BYLAW**

#### Recommendation

- 1. That Bylaw 20581 be given the appropriate readings.
- 2. That the City policies listed in Attachment 2 of the October 24, 2023, Office of the City Clerk report OCC01966, be repealed and/or amended, as specified in Attachment 2.
- 3. That the motions listed in Attachment 3 of the October 24, 2023, Office of the City Clerk report OCC01966, be rescinded.

## **Purpose**

Twice a year, Administration presents a report to Council to amend or repeal, as applicable, bylaws and/or policies that have expired or are otherwise no longer relevant, to rescind expired or redundant motions and/or to amend clerical errors.

# **Readings**

Bylaw 20581 is ready for three readings.

A majority vote of City Council on all three readings is required for passage.

If Council wishes to give three readings during a single meeting, then prior to moving third reading, Council must unanimously agree "That Bylaw 20581 be considered for third reading."

#### **REPORT**

This report provides for the correction of information and errors in bylaws, the repeal and amendment of City policies and the rescission of expired or redundant motions.

The Office of the City Clerk coordinates the general repealing review with Administration and will continue to bring similar reports to Council twice per year.

Bylaw 20581 is in Attachment 1. Administration identified zero bylaws that need to be repealed and two bylaws that need to be amended. The Bylaws to be amended are:

- Bylaw 5590 Traffic Bylaw is amended by:
  - In section 2(r.1), providing an update to the definition of "parking ban" for clarity.

- Bylaw 19870 Council Committee Code of Conduct is amended by:
  - Removing section 3(I.1) "Office of the Councillors Budget Review Task Force."
