

## BYLAW 20633 - TO DESIGNATE PICNIC SHELTER #2 AS A MUNICIPAL HISTORIC RESOURCE

### Recommendation

That Executive Committee recommend to City Council:

That Bylaw 20633 be given the appropriate readings.

### Purpose

To designate Picnic Shelter #2 as a Municipal Historic Resource pursuant to the provisions of the *Historical Resources Act*, RSA 2000, cH-9.

### Readings

Bylaw 20633 is ready for three readings.

A majority vote of City Council on all three readings is required for passage.

If Council wishes to give three readings during a single meeting, then prior to moving third reading, Council must unanimously agree “That Bylaw 20633 be considered for third reading.”

### Position of Administration

Administration supports Bylaw 20633.

### Report Summary

This Bylaw designates Picnic Shelter #2 in William Hawrelak Park as a Municipal Historic Resource. The City of Edmonton is the owner of the structure.

## REPORT

Upon passage of Bylaw 20633, Picnic Shelter #2 in William Hawrelak Park will be designated a Municipal Historic Resource and the Rehabilitation and Maintenance Agreement (Schedule “B” of Attachment 1) will be approved and come into effect. The designation of Picnic Shelter #2 is being undertaken with the designation of other structures on the site as Municipal Historic Resources, including the Main Pavilion, Boat House, Picnic Shelter #1 and Picnic Shelter #3.

## **BYLAW 20633 - To Designate Picnic Shelter #2 as a Municipal Historic Resource**

Picnic Shelter #2 is listed on the Inventory of Historic Resources in Edmonton and merits designation under City Policy C450B - Policy to Encourage the Designation and Rehabilitation of Municipal Historic Resources in Edmonton. The structure was constructed in 1968 as a Canada Centennial project, and features Organic Modern/International Style influences.

The City of Edmonton, the owner, has completed the application requirements to have Picnic Shelter #2 designated as a Municipal Historic Resource under the provisions of City Policy C450B.

The regulated portions of the structure, as outlined in Schedule "A" of Attachment 1, will be preserved and maintained. Any future renovation of Picnic Shelter #2 will be required to meet the *Standards and Guidelines for the Conservation of Historic Places in Canada*.

### **Community Insight**

Through the creation of The City Plan, Edmontonians advised that it was critical to retain and steward historic resources even as the City is redeveloped and modernized, recognized as The City Plan value of "Preserve." Engagement with the public for this process is not a requirement under the *Historical Resources Act*.

### **Budget/Financial Implications**

No funding from the Heritage Resources Reserve is being provided for the costs of the rehabilitation of the structure. The rehabilitation work for this structure is funded under capital profile 21-32-9101 William Hawrelak Park Rehabilitation, project number CP-008826.

### **Legal Implications**

Once the Bylaw 20633 - Bylaw to Designate Picnic Shelter #2 as a Municipal Historic Resource is passed, Picnic Shelter #2 will be designated a Municipal Historic Resource and the City, as owner, will be responsible to comply with the provisions of the *Historical Resources Act*.
