Zoo by the Numbers




- 348,000 visitors
- 7,900 members
- 900 school programs with 21,000 students
- 246 volunteers log hours
- 22,000 social media followers
- 225 animals representing 84 species
- 10 species survival programs

2005 Master Plan Results

- Attendance growth: 178%
- Revenue growth: 354%
- Attendance up 58% since Arctic Shores
- Tax Levy down by 10% since 2019








Zoo Ownership and Operation






- Zoning restrictions

Industry Review



- Continuum of partner involvement
- Partners support fundraising, retail services, special events and rentals
- Maintenance and animal care delivered largely by the municipality
- Few partners lead capital projects, deliver education programs, security and communications
- In all cases, the owner provides fiscal support for operations, maintenance and capital growth

- Operational model that utilizes revenue generating business to offset expense budget to maximize donations made to the Zoo going 100% to the Zoo.


