

Charter Bylaw 20703

A Bylaw to amend Charter Bylaw 20001,
The Edmonton Zoning Bylaw
Amendment No. 2

WHEREAS the lands shown on Schedule "A" and legally described on Schedule "B" are within the neighbourhoods of Garneau, Ambleside and Paisley, in Edmonton, Alberta; and

WHEREAS an application was made to rezone the above described properties to (RM h23.0) Medium Scale Residential Zone, (ALA) Ambleside Low-Rise Apartment Zone and (PRH) Paisley Row Housing Zone;

NOW THEREFORE after due compliance with the relevant provisions of the Municipal Government Act, RSA 2000, ch. M-26, as amended, the Municipal Council of the City of Edmonton duly assembled enact as follows:

1. Notwithstanding Charter Bylaw 21001, the lands legally described on Schedule "B" shall be zoned in accordance with that Schedule, effective January 1, 2024.

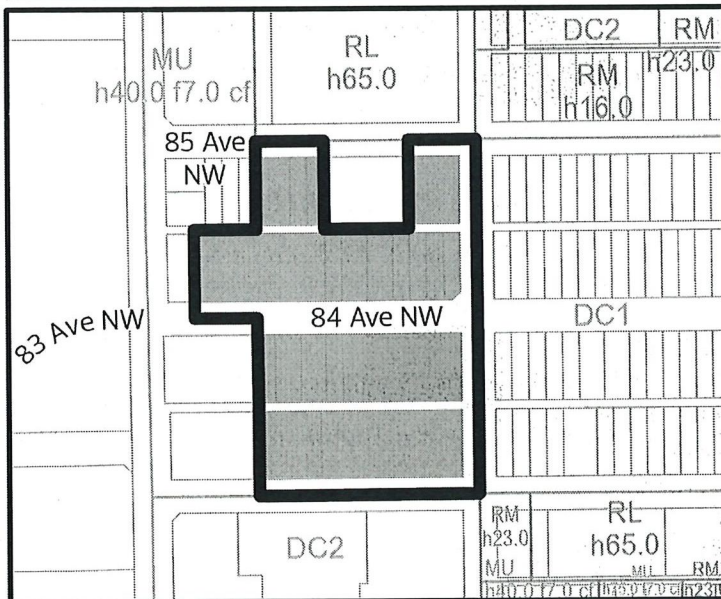
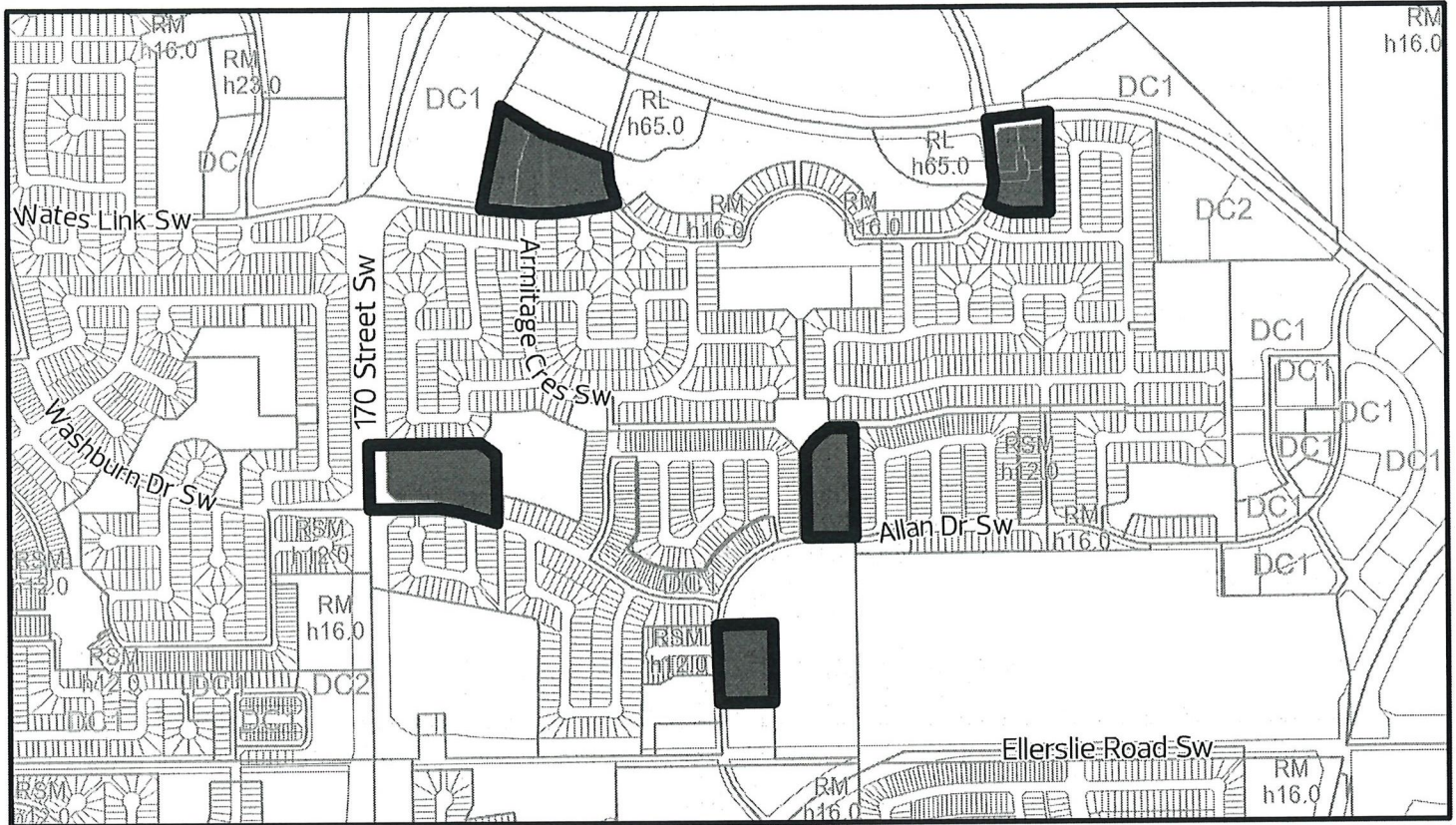

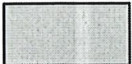
