
## **Single-use Item Survey Data**

### **Resident Survey**



A total of 7,917 respondents completed the survey.


Q1 - Before today, were you aware that Edmonton has a bylaw to reduce the use of single-use items? (7,917 responses)





Q3 - Do you feel that Edmonton's Single-use Item Reduction Bylaw is a reasonable measure to help reduce waste? (7,917 responses)




Q4 - How often do you bring your own reusable cup for takeout beverages? (7,917 responses)




#### Retail




Q5b - Why do you never bring your own reusable shopping bags when you shop? (OPEN TEXT)



Q5d - How often are you paying the minimum \$1 fee for reusable shopping bags? (7,917 responses)




#### **Food Service**




Q7b - If you never bring your own reusable shopping bags for takeout or drive-thru orders, why not? (OPEN TEXT)


Q7c - How often are you paying the fee for a paper bag for takeout or drive-thru? (7,917 responses)



Q7d - How often are you paying the fee for a reusable bag for take out or drive thru? (7,917 responses)










D2 - Which of the following categories best describes your total household income in 2022 before taxes? (7,712 responses)




### **Business Survey**


Q1 - Tell us about your business... Please select your current operating markets. Select all that apply. (216 responses)



### Q2 - Is your business a franchise? (216 responses)




## Q3 - What is your main industry? - Selected Choice (216 responses)






Q5 - How has your use of single-use items changed since the bylaw took effect on... (177 responses)




Q5\_x1 - Single-use cups (97 responses)




Q5\_x2 - New paper bags (134 responses)



Q5\_x3 - New reusable bags (64 responses)




Q5\_x4 - Foodware accessories (including cutlery, napkins, straws) (114 responses)








Q7b - Why is consistency of bag fees between municipalities important for you? (OPEN TEXT)



Q9 - How much LOWER would you expect your business' use of bags would be as a result of the fee increase on July 1, 2024? (43 responses)




Q10a - How would you rate your business' support for the next proposed fee increase on July 1, 2024? (177 responses)


