Mandate

The mandate of the Edmonton Combative Sports Commission (ECSC), as stated in Bylaw 15638 - Edmonton Combative Sports Commission Bylaw is to control and regulate all aspects of Combative Sports and Events in the city, including:

- a. hearing appeals from the Executive Director's licensing and permitting decisions;
- b. approving Regulations governing the:
 - i. licensing criteria and requirements for all aspects of Combative Sports and Events:
 - ii. conduct of Promoters, Contestants, and other Persons participating in Combative Sports or attending Events;
 - iii. credentials, qualifications and selection processes for Officials;
 - iv. Contests;
 - v. disciplinary proceedings and sanctions;
 - vi. internal Commission procedures and governance; and
 - vii. any other matter relating to the control or regulation of Combative Sports and Events in the city.

Annual Report and Work Plan Requirements

Bylaw 18156 - Council Committees Bylaw (Bylaw 18156), sets out the annual reporting requirements for Council Committees. Under Bylaw 18156, all Council Committees:

- Will report to Council at least annually.
- Must approve a work plan that aligns with Council's strategic objectives and the Council Committee's mandate, including a reporting of what resources were provided in the previous year and the anticipated resource requirements for the upcoming year.
- During its annual report to Council, must present their work plan as well as a summary of the status of their previous year's work plan.

Resources for Council Committees

Council Committees were provided with templates to support drafting annual reports, resource information and work plans in alignment with the requirements in Bylaw 18156. The templates are a part of the Administrative response to the Civic Agencies Governance Audit, Recommendation 3 (see the November 30, 2023, Office of the City Clerk report OCC02137).
