#### Message from the Chair:

I am happy to present the annual report of the activities of ETSAB for the year 2023. This year we are fortunate to have a complete roster of 12 board members, with three members beginning their term last May.

Both the new and continuing board members worked together to produce deliverables and engage meaningfully during meetings.

This is the second year of implementing the change in schedule of the Annual Retreat. ETSAB had their annual retreat in September 2023, and as a result, the time period of the board's activities range from October 2023 - September 2024. The difference in the time period of the activities and the time period for the reports are reflected accordingly.

The Chair conducted periodic one-on-one check-in meetings with both new and returning board members to provide support and build a productive working relationship. Beginning January 2024, the board meetings are conducted in a hybrid fashion to provide flexibility for board members and members of the public.

ETSAB's activities and reports highlighting opportunities to improve transit services and experiences, outlined in further detail below, have been well received by Council and Administration. ETSAB looks forward to seeing many of the recommendations implemented and to continuing these collaborative efforts in 2024-25.

### **Purpose of the Annual Report**

This annual report has been developed to meet the requirements of Bylaw 18156 - Council Committees Bylaw, which sets out the annual reporting requirements for Council Committees. Under Bylaw 18156, all Council Committees will:

- Report to Council at least annually.
- Approve a work plan that aligns with Council's strategic objectives and the Council Committee's mandate, including a reporting of what resources were provided in the previous year and the anticipated resource requirements for the upcoming year.
- Report to Council and during its annual report to Council, a Council Committee must present the work plan as well as a summary of the status of the previous year's work plan.

### Mandate of Edmonton Transit Service Advisory Board (ETSAB)

The mandate of ETSAB will be to provide advice to Council from a stakeholder perspective on issues related to public transit, including:

- (a) ridership;
- (b) mix of vehicles;
- (c) the relationship between City projects and public transit;
- (d) reviewing initiatives of other levels of government, surrounding municipalities, and other local authorities or organizations that could affect public transit;
- (e) repair, maintenance and accessibility issues;
- (f) servicing issues; and
- (g) public transit policies.

## Report on 2023 Work Plan Goals and Accomplishments

ETSAB held twelve regular monthly meetings in the 2023-2024 term. Through a series of activities during and in between regular monthly meetings, the board conducted several activities in order to stay informed on transit-related matters, organize the board members, and produce deliverables to provide input on how to improve public transit in Edmonton.

The board completed the work on the following subcommittees/ working groups that were carried over from the previous year:

- Budget
- Youth and Their Perception of Safety on ETS
  - Note: This report included consultation with Edmonton Youth Council

The board started and completed the work on the following subcommittees/ working groups in 2023:

- A Review of Winter Mobility and Accessibility of Pathways to Transit Stops
- Ridership Improvement Strategies
  - Note: This report included consultation with Edmonton Youth Council,
     Women's Advocacy Voice of Edmonton and Accessibility Advisory Committee

The board's work on the following subcommittees/ working groups is underway and will be completed shortly after the submission of this report:

- Fare Evasion
- Perception of Safety in LRT

ETSAB members also participated in several activities and events throughout the year.

- The Chair presented at the Transit Camp conference about the goals and contributions of an advisory board like ETSAB consisting of everyday residents passionate about transit.
- Provided feedback on various transit-related topics discussed by Urban Planning Committee and Executive Committee.
- The board had the Annual Luncheon with City Council in November which was a valuable opportunity for ETSAB board members and city councillors to meet and share perspectives on public transit and the plans of the municipal government.
- Edmonton hosted the Canadian Urban Transit Association fall convention. While in previous years, two board members were able to attend, 6 board members were able to attend this year and experienced the opportunity to learn about transit matters, network with members of the industry and transit providers, and take pride in the transit amenities that ETS showcased to the delegates.

Board Chair Giselle will be a part of the session, and are encouraging other members to participate and attend if available.</li> <li>As Edmonton will be hosting the CUTA (Canadian Urban Transit Association) conference this fall, the board agreed to have a regular agenda item to discuss attendance and participation as well as brainstorm ideas for more ETS or city involvement in this conference. The goal is to be able to send more members than normal because of this opportunity of hosting locally.</li> <li>Received a summary of the Canadian Urban Transit Conference 2023 from ETS staff who attended.</li> <li>The Budget sub-committee met earlier in the month and aims to present a report to the rest of ETSAB by the March general meeting, and present this report to council in the near future.</li> <li>The Winter Accessibility sub-committee is wrapping up data collection as the final month of winter approaches, and will be reviewing recorded experiences to see if patterns emerge. Board Chair Giselle General updated ETSAB on the Annual Report and Annual Work Plan presented to Council earlier in the month. • The Board received more information about the process changes in regard to Civic Board sub-committees. The board discussed actions moving forward and found that while members were not too certain about the specific changes that need to be taken, members believe they will receive the proper support. City administration liaisons and Councillor Rutherford offered good comments during this discussion. **<u>Key Motion</u>**: The Board voted unanimously to approve the report written by the Budget sub-committee. May (June 5 **Presentations:** ETSAB received a presentation from Valerie Dacyk on pushed by 1 Bus Stop Winter Maintenance. The board was very attentive and week) interested in Valerie's presentation, especially for the Winter Accessibility and Mobility working group. This was the first official ETSAB general meeting for 3 new board members. The board members and ETS representatives welcomed Eugene Masakhwe, Bailey Gerrits, and Maria Owczarek. ETSAB looks forward to their transit insight and participation for the next year. **Key Motion**: The Board voted unanimously to approve the Winter Accessibility and Mobility report, and the next steps will be delivering the report and finding an appropriate meeting to present it. June **Presentations:** The board received a presentation on the Community Outreach Transit Teams (COTT) and learned about their development during this two-year pilot. Board members raised various questions, and are looking forward to learning more about COTT as the board prepared to launch a working group that is centered around this service. Board members have signed up to their respective working groups that will be starting shortly. The next topics of interest will be reviewing the COTT service and ridership improvement strategies. Board Chair Giselle General updated ETSAB on the DATS Advisory Group, ongoing communications with a transit and disability advocate, and future actions that the board can take for addressing disability issues in transit. Moving forward, ETSAB will receive quarterly updates on DATS in the ETS Branch Highlights. Ongoing liaison relationship is reestablished with the Accessibility Advisory Committee. ETSAB board member Zohra Jabeen and AAC

	board member Douglas Rudolph have been attending both board meetings and the rest of the board members are very grateful for their time and dedication. ETSAB was appreciative that AAC addressed concerns about snow and ice removal plans at the latest Community and Public Services Committee meeting. ETSAB's working group on accessibility of pathways and bus trips during winter conditions align with the concerns raised by AAC.
July	<ul> <li>The board submitted an application to present at the upcoming CUTA conference, and if chosen, will be highlighting the functions of a civic advisory board such as ETSAB.</li> <li>The board had chosen September 9 for the next retreat to choose the next working group topics. Not all members are able to attend, however, the organizers will facilitate a process to submit topics for consideration before the official retreat because it is very important that all board members have the opportunity to voice their interests.</li> <li>Key Motion: The board approved the Terms of References for the Ridership Improvement Strategies working group. The board is always happy to offer feedback on upcoming committee and council reports and appreciates Councillor Rutherford for reaching out and taking in the board's input.</li> <li>Marc Lachance of ETS gathered responses for the board members' follow-up questions after the first presentation on transit improvements from an Edmonton resident from April 2023. After these responses and information are recorded in the August general meeting minutes, the Chair will pass along the document to the Edmonton resident to show that we followed up on the questions after their presentation.</li> <li>ETSAB's annual retreat will be held on Sept 9. staff have been integral in arranging the final details so that the board can gather and choose the next working group topics. Board members can anticipate a few emails about the retreat leading up to the date so that the executives can get everyone's input on topics, especially from the board members that will not be able to attend. ETSAB will not be presenting at the upcoming CUTA conference and will focus efforts on sending board members so that they can attend talks and presentations. The board is looking forward to learning more about the transit landscape in other municipalities in Canada. The Ridership Improvement Strategies working group are hoping to start their report in the upcoming weeks. Their next step is sorting out their research, and appreciate the support from grad student Stephanie. They also talked about their interaction with Edmonton Insight Community and discussed the potential gains that the board could have if they are able could collaborate further in the future. September • ETSAB received an update from Councillor Rutherford, who recently attended the Canadian Urban Transit Association's Policy Forum in Ottawa where the intersection of housing and transit was discussed, including how different levels of government can support density around transit centres. Councillor Rutherford also provided information about Edmonton's upcoming Zoning Bylaw Renewal and how it relates to Edmonton's transit plan. ETSAB's annual retreat was held on September 9th. Board members debriefed on the event and discussed what went well and what could be improved. Three subcommittee topics have been chosen, and the fourth will be decided on at a later date following work on the initial topics. A sign-up sheet will be set up for board members to sign up for the upcoming topics. • The report on Mobility and Accessibility in Edmonton Winters will be presented to the Urban Planning Committee on October 11. • A draft of the Ridership Improvement Strategies (which incorporated feedback that was received) was recently distributed to board members; board members are encouraged to review the draft and provide additional feedback. A copy was provided to AAC, WAVE and EYC for additional insights. It will be voted on via email so that, if approved, a final version can be submitted to administration two months prior to the presentation date of December 5th. October **Presentations:** ETSAB received 3 presentations with comprehensive questions from the board.
