- The mandate of the Edmonton Design Committee (EDC) is to improve the quality of the City's urban design by providing:
 - **Recommendations regarding development applications and**
 - **Advice regarding urban design policies and principles.**

- Reviewing development applications (rezoning applications, development permits and City projects) in accordance with EDC Bylaw 20673, EDC Standards and Procedures and the EDC Principles of Urban Design
 - **8 Rezoning (5 Formal, 3 Informal) and 14 Development Permits (10 Formal, 4 Informal)**
 - **6 formal City project submissions: Warehouse Park; Beaver Hills Park; Police Seized Vehicle Lot Administration Building; Blatchford Fire Station; 81 Avenue Reconstruction; 107 Avenue Public Park**
