Bylaw 17596

Closure of portions of lanes north of 110 Avenue NW and east of 113 Street NW; Queen Mary Park.

WHEREAS the Municipal Council of the City of Edmonton may pass a Bylaw for the purpose of closing any road provided that the bylaw is advertised and any person who claims to be affected prejudicially by the bylaw, or their agent, has been given an opportunity of being heard by City Council in relation to the proposed Bylaw; and

WHEREAS City Council has considered the proposed closing and has agreed that it is in the public interest to pass this Bylaw;

NOW THEREFORE the Municipal Council of the City of Edmonton, duly assembled, enacts as follows:

1. All that portion of road, generally as shown on Schedule "A" described as follows:

Firstly:

Plan 2109HW Block 12a All that portion of the east/west lane which lies west of a straight line, connecting a point on the north limit of lot 34 in said block lying 22.96 metres east of the northwest corner thereof with a point on the south boundary of lot 12 in said block lying 16.96 meters west of the southeast corner thereof and which also lies east of a line connecting a point on the north limit of lot 38 in said block lying 8.01 metres west of the northeast corner thereof with a point on the south boundary of lot 8 in said block lying 6.19 meters west of the southeast corner thereof

Secondly:

Plan 2109HW All that portion of the north/south lane which lies south of a line drawn from the north east corner of lot 36 to the north west corner of lot 35, block 12A, said plan

EXCEPTING THEREOUT ALL MINES AND MINERALS.

IS HEREBY CLOSED.

2. When title or titles are created for the former portion of road as described in Section 1 of this Bylaw, it is understood and agreed that such title or titles for the former portion of road may be issued excepting Mines and Minerals, the City however, reserving the right to the said Mines and Minerals if in fact the City is the owner thereof.
