# **Bylaw 17717**

To amend Bylaw 17256, to authorize the City of Edmonton to finance the Francis Winspear Centre for Music Construction Project

#### **Purpose**

To amend Bylaw 17256 by decreasing the borrowing authority by \$12,100,000 from \$25,000,000 to \$12,900,000.

## Readings

Bylaw 17717 is ready for three readings.

If Council wishes to give three readings during a single meeting, then prior to moving third reading, Council must unanimously agree "That Bylaw 17717 be considered for third reading".

# **Advertising and Signing**

This Bylaw does not require advertising and the Bylaw can be signed and thereby passed following third reading.

Section 258(5) of the *Municipal Government Act* states that if "the increased cost does not exceed 15% of the original cost of the property, the borrowing bylaw that authorizes the borrowing of the increased cost does not have to be advertised". Given that the borrowing authority has decreased, advertising is not required.

#### **Position of Administration**

Administration supports this Bylaw.

#### Report Summary

This Bylaw amendment will decrease the borrowing authority for the Francis Winspear Centre for Music Construction Project, by \$12,100,000 from \$25,000,000 to 12,900,000.

#### **Previous Council/Committee Action**

At the June 20, 2016, Community Services Committee meeting, the following motion was passed:

That Administration prepare an amended borrowing bylaw, amended loan bylaw and amended terms for the loan agreement with the Francis Winspear Centre for Music in accordance with the revised request, as outlined in the June 20, 2016, Financial and Corporate Services report CR\_3596.

#### Report

At the November 17, 2015, City Council meeting, Bylaw 17256 was passed.

This bylaw amendment will decrease borrowing authority for the Francis Winspear Centre for Music Construction Project by \$12,100,000 from \$25,000,000 to \$12,900,000 to align with the revision to the parking solution component of the project as presented

If Bylaw 17718 does not proceed, Bylaw 17256, as amended, will be repealed.
