BYLAW 20740

Bylaw 20740 to amend Revised Bylaw 18985, City of Edmonton
Community Revitalization Levy Projects, Downtown CRL,
Amendment #7

WHEREAS:

- A. The Council of the City of Edmonton on November 5, 2019 duly passed Revised Bylaw 18985, as amended by Bylaw 19240 duly passed on June 22, 2020, as amended by Bylaw 20048 duly passed on May 9, 2022, as amended by Bylaw 20107 duly passed on May 24, 2022, as amended by Bylaw 20217 duly passed on August 15, 2022, as amended by Bylaw 20488 duly passed on June 13, 2023, as amended by Bylaw 20566 duly passed on October 4, 2023, authorizing the City of Edmonton to undertake, construct and finance Community Revitalization Levy Projects, Downtown CRL (the “Projects”), and also authorizing the Mayor and Chief Administrative Officer to borrow the sum of \$70,858,000.00 for a period of twenty (20) years with the principal and interest to be repaid in semi-annual or annual instalments;
- B. The borrowing authority for the Projects will be decreased by \$15,031,458.00 from \$70,858,000.00 to \$55,826,542.00. Furthermore, the total cost of the Projects is now \$59,554,694.00 as a result of previously approved adjustments.

THEREFORE, THE COUNCIL OF THE CITY OF EDMONTON DULY ASSEMBLED
ENACTS AS FOLLOWS:

1. Revised Bylaw 18985 is amended in the preamble, Section (B), thereof by deleting the figure “\$74,237,000.00” as it appears and by substituting the figure “\$59,554,694.00”.
2. The said Bylaw is further amended in the preamble, Section (D) and in Sections (1), (2) and (10), thereof by deleting the figure “\$70,858,000.00” as it appears and by substituting the figure “\$55,826,542.00”.
3. The said Bylaw is further amended by replacing Schedule “A” with Schedule “A” as attached.

4. This Bylaw shall take effect on the day of the final passing thereof.
