





# Climate Accountability Frameworks are an emerging practice

- 2021 Canadian Net-Zero
  Emissions Accountability Act
- 2023 United Nations Framework for Non-Party Stakeholders
- Public Sector Accounting Board beginning to develop climate-related disclosure standards

- Recruiting a Chief Climate Officer
- Developing a corporate accountability matrix for each level in the organization
- Developing recommendations to enhance climate governance, decision making, roles and responsibilities, performance and accountability



## **Identifying Training and Climate Competencies**

# Climate change is changing how municipalities need to work

- Requires new skills and competencies
- Continues to evolve with new knowledge and technology
- The market has started to offer some climate training (e.g. Energy manager, climate risk assessment)

- Training staff in key roles (where training exists in the market)
- Sharing broad information and hosting awareness sessions for staff
- Participating in Peer Learning Networks
- Completing a training needs assessment
- Developing an introductory climate training course for all staff



## **Implement Formal Monitoring and Evaluation Framework**

# Climate analysis and tracking is rapidly becoming more sophisticated

- New research, new modelling, new disciplines, new tools
- Not all actions need the same level of targets or tracking
- Adaptation targets are an emerging field and are not universal, need to be localized
- 2023 Canada's Adaptation Strategy released with targets

- Recognized for its climate data and reporting
- Working on a climate tracking, evaluation and analytics framework
- Including adaptation targets as part of the strategy update



## **Improving Climate Information for Decision Makers**

# Treating every decision as a climate decision requires the right climate information at the right time

- IPCC Cities and Climate Science conference put local climate research on the international agenda
- Carbon and climate budgeting is an emerging field
- Recognize and incorporate
  Indigenous and ecological knowledge
  and systems

- Improving carbon budget processes
- Establishing a new Environment and Climate section in Council Reports
- Establishing a new process at the start of City projects
- Developing an environment and climate information and data repository
