MINISTERIAL ORDER NO. H:024/20 DEPARTMENT OF SENIORS AND HOUSING PROVINCE OF ALBERTA ALBERTA HOUSING ACT GEF SENIORS HOUSING

I, Josephine Pon, Minister of Seniors and Housing, pursuant to section 5 of the Alberta Housing Act, make the following order:

- 1. Ministerial Order No. H:158/95, as amended, establishing the Greater Edmonton Foundation as a management body, is amended as follows:
 - a) by changing the name of the Greater Edmonton Foundation to GEF Seniors Housing.
 - b) by replacing the Appendix attached to Ministerial Order No. H:158/95 with the attached Appendix, dated August 1, 2020.
 - c) by replacing the Schedule "A" attached to Ministerial Order No. H:158/95 with the attached Schedule "A," dated August 1, 2020.
- 2. This Ministerial Order comes into effect on the date it is signed by the Minister.

APPENDIX

GEF Seniors Housing

- GEF Seniors Housing (hereafter referred to as the "management body") is hereby established as a management body.
- 2. The City of Edmonton is the only member of the management body.
- (1) The management body shall be governed by a board (hereafter referred to as the "board"), comprised of a maximum of nine (9) members appointed by the Council of the City of Edmonton ("City Council") and in accordance with subsection (2).
 - (2) The board shall be appointed as follows:
 - (a) For the purposes of appointing members of the board, the City Council shall determine the method of appointment.
 - (b) Members of the board will be appointed for terms of up to three years.
 - (c) Members of the board may hold consecutive terms of office as long as their aggregate years of service do not exceed a maximum of six (6) years.
 - (d) If the office of a board member is vacated, the City Council shall appoint, on the vacancy occurring or as soon as possible thereafter, another individual as a member of the board to complete the term of a vacating member.
 - (e) The chairperson, vice-chairperson and any other officers of the board, that the board determines are necessary shall be appointed from among the board members in the manner and at the times the board determines appropriate.
 - (f) The term of office for the chairperson, vice-chairperson or any other officers of the board shall be for a one (1) year term.
 - (g) Subject to Clause (2)(c), the chairperson, vice-chairperson and any other officers of the board may hold consecutive terms of office as long as each officer is a member of the board.
 - (h) Each member of the board is entitled, at meetings of the Board, to participate in all matters arising from the policies, program, operation and administration of the management body, except where otherwise provided under the Act and its Regulations.
 - (3) The board is a continuing body.
 - (4) The board shall provide the Deputy Minister and the City Manager of the City of Edmonton with the name of its chairperson and vice-chairperson as soon as possible on selection, and shall notify the Deputy Minister and the City Manager of any change of chairperson and vice-chairperson.
- 4. The board shall:
 - (a) designate the offices of the management body, and
 - (b) immediately notify the Deputy Minister and the City Manager of the City of Edmonton of the location of its primary place of business in Alberta and any other offices, the management body's address for service and any change in the location of such offices or address for service.
- Notwithstanding any prior agreements between the Provincial Crown and the City Council respecting the operations of GEF Seniors Housing:

August 1, 2020

- (1) Within 30 days of GEF Seniors Housing's establishment as a management body and, thereafter, at least 90 days prior to the end of every following 3-fiscal-year period, the board shall provide the City Manager of the City of Edmonton with a copy of GEF Seniors Housing's 3-fiscal-year business plan as required under Sections 16(1) and 16(2) of the Management Body Operation and Administration Regulation of the Alberta Housing Act for submission to City Council for its approval.
- (2) That, at least 90 days before January 1st of the next fiscal year, the board shall adopt an Operating Budget for that fiscal year and submit a copy to the City Manager of the City of Edmonton for submission to City Council for its approval. The Operating Budget shall include an estimate of the following items for the lodge accommodation which GEF Seniors Housing intends to requisition the City of Edmonton for operating deficit funds:
 - (a) the amount needed to cover the lodge accommodation operating expenses, including administration;
 - (b) the amount needed to pay the costs of any borrowing to acquire, construct, or improve capital property;
 - (c) any amounts to be transferred to reserves;
 - (d) the amount of rent and all other payments received from tenants;
 - (e) the amount of Lodge Assistance Program grant funds and any other operating funds or program funds to be provided by the Province;
 - (f) the amount of surplus funds;
 - (g) the amount of operating deficit funds to be requisitioned from the City Council;
 - (h) any other operating budget information requested by the City Manager of the City of Edmonton or City Council acting reasonably.
- (3) That at least 90 days before January 1st of the next fiscal year, the board shall adopt a Capital Budget for that fiscal year and submit a copy to the City Manager of the City of Edmonton for submission to City Council for its approval. The Capital Budget shall include an estimate of the following items for the Lodge Accommodation which GEF Seniors Housing intends to requisition the City for capital or capital debt payment funds:
 - (a) the amounts needed to acquire, construct, or improve capital property, and a detailed breakdown of the proposed expenditures;
 - (b) any amounts to be transferred to reserves;
 - (c) the amount of funds to be requisitioned from the City of Edmonton to pay the costs referred to in (a) above and the amount of funds to be provided from other sources; and
 - (d) any other capital budget information requested by the Office of the City Manager of the City of Edmonton or City Council, acting reasonably.
- (1) Within 60 days of the receipt of the Operating and Capital Budgets submitted under Sections 5(2) and 5(3), City Council shall approve the Operating and Capital Budgets as submitted or shall advise the board of those items for which revisions are necessary.

August 1, 2020

- (2) The board shall prepare and submit to the City Council for approval a revised budget within the time specified by City Council.
- 7. The board may amend an approved operating or capital budget, such amendments to be effective only upon approval of City Council.
- The board or its designate may only initiate or pay an expenditure that is included within an Operating or Capital Budget approved by City Council, unless the same is an emergency expenditure otherwise approved by City Council or its designate either before or after the same is paid.
- 9. The management body, for the purposes of providing lodge accommodation, may requisition the City as directed under Section 7(1) of the Act and subject to Sections 5, 6 and 7 of the Appendix to this Ministerial Order.
- 10. The management body is responsible for the operation and administration of the housing accommodation listed in Schedule "A"
- 11. In addition to the housing accommodation operated under Section 10, the management body:
 - (a) may operate Rent Supplement housing accommodation as designations are allocated to the management body by the Minister under the Rent Supplement
- 12. For the purposes of the Act, the management body has and is subject to the powers, functions, or duties as provided in the following Regulations and amendments
 - (a) Management Body Operation and Administration Regulation;
 - (b) Social Housing Accommodation Regulation;
 - (c) Housing Accommodation Tenancies Regulation;
 - (d) Lodge Assistance Program Regulation; and
 - (e) Rent Supplement Regulation.
- 13. For the purposes of the Act, the management body's reporting date is 90 days from the effective date of this Order.
