

BYLAW 20909 - FALL 2024 GENERAL REPEALING BYLAW

Recommendation

1. That Bylaw 20909 be given the appropriate readings.
2. That the Council Policies listed in Attachment 2 of the October 22, 2024, Office of the City Clerk report OCC02549, be repealed or amended as specified.
3. That the motions listed in Attachment 3 of the October 22, 2024, Office of the City Clerk report OCC02549, be rescinded.

Purpose

Twice a year, Administration presents a report to Council to:

- amend or repeal, as applicable, bylaws and/or policies;
- rescind expired or redundant motions and inquiries; and/or
- amend clerical errors in bylaws and/or policies.

Readings

Bylaw 20909 is ready for three readings.

A majority vote of City Council on all three readings is required for passage.

If Council wishes to give three readings during a single meeting, then prior to moving the third reading, Council must unanimously agree “That Bylaw 20909 be considered for third reading.”

REPORT

The Office of the City Clerk coordinates the general repealing review with Administration. This report documents the results of this review with recommendations on the appropriate action.

Bylaw 20909 proposes to amend the following four bylaws:

- Bylaw 20002 - Business License Bylaw:
 - Schedule C - “Cannabis Retail Sales” is amended to delete a reference to section 42(a), a section within the bylaw that was deleted (pg. 61).
- Bylaw 18156 - Council Committees Bylaw:

- Is amended in section 5(2.1) to provide some flexibility in member term appointments by qualifying that “Members of Council Committees will be appointed for **up to** two-year terms” (emphasis added).
- Bylaw 19091 - Emergency Management Bylaw:
 - Is amended to reflect the current position titles for the members of the Emergency Management Agency.
- Bylaw 14600 - Community Standards Bylaw:
 - Is amended to delete section 12.4 - Waste Container Storage to remove a contradictory provision with section 32.4(4) on the permitted storage location of waste containers on private property.
