## **BYLAW 20620**

Bylaw 20620 to amend Bylaw 16117, City of Edmonton Waste

Management Projects, Edmonton Waste Management Centre Facility

Upgrade and Material Recovery Facility Renewal

## WHEREAS:

- A. The Council of the City of Edmonton on July 4, 2012 duly passed Bylaw 16117, authorizing the City of Edmonton to undertake, construct and finance Waste Management Projects, Edmonton Waste Management Centre Facility Upgrade and Material Recovery Facility Renewal (the "Projects"), and also authorizing the Mayor and Chief Administrative Officer to borrow the sum of \$14,792,000.00 for a period of fifteen (15) years with the principal and interest to be repaid in semi-annual or annual instalments;
- B. It has now been determined that the Projects are completed with a total cost of \$14,080,243.45. The borrowing authority for the Projects will be decreased by \$807,744.55 from \$14,792,000.00 to \$13,984,255.45.

THEREFORE, THE COUNCIL OF THE CITY OF EDMONTON DULY ASSEMBLED ENACTS AS FOLLOWS:

- Bylaw 16117 is amended in the title and in the preamble, paragraph one, thereof by deleting the words "Waste Management" as it appears and by substituting the words "Waste Services".
- 2. The said Bylaw is further amended in the preamble, paragraphs two and four, thereof by deleting the figure "\$14,792,000.00" as it appears and by substituting the figure "\$14,080,243.45".
- 3. The said Bylaw is further amended in the preamble, paragraph seven, thereof by deleting the paragraph "The amount of the existing debenture debt of the City of Edmonton at December 31, 2011 is \$1,973,819,478.46, as calculated in accordance with the *Debt Limit Regulation*, A.R. 255/2000, as amended, no part of which is in arrears;" as it appears and by substituting a new paragraph "The amount of the existing debenture debt of the City of Edmonton on December 31, 2023 is \$4,167,485,798.43 as calculated in accordance with the City of Edmonton Debt Management Fiscal Policy C203D, no part of which is in arrears;".
- 4. The said Bylaw is further amended in Sections (1) and (2), thereof by deleting the figure "\$14,792,000.00" as it appears and by substituting the figure "\$13,984,255.45".
- 5. The said Bylaw is further amended in Section (5), thereof by deleting the second sentence: "The Mayor and the City Manager shall authorize such bank or financial institution to make payments to the holder of the debentures, on such date and in such amounts as specified in the repayment schedule forming part of each debenture." as it appears and by substituting the new second sentence: "At least two of the following positions; the Mayor, the Chief

Financial Officer, or the City Manager, shall authorize such bank or financial institution to make payments to the holder of the debentures, on such date and in such amounts as specified in the repayment schedule forming part of each debenture."

- 6. The said Bylaw is further amended in Section (6), thereof by deleting the paragraph: "The debentures shall be signed by the Mayor and the City Manager of the City of Edmonton and the City Manager shall affix thereto the corporate seal of the City of Edmonton to the debentures." as it appears and by substituting the new paragraph: "The debentures shall be signed by at least two of the following positions: the Chief Financial Officer, the City Manager or the Mayor of the City of Edmonton and the City Manager shall affix thereto the corporate seal of the City of Edmonton to the debentures."
- 7. The said Bylaw is further amended in Section (7), first and second sentences, thereof by deleting the words "management" and "utility rate bylaw" as it appears and by substituting the words "services" and "Waste Services bylaw".
- 8. The said Bylaw is further amended by replacing Schedule "A" with Schedule "A" as attached.
