Bylaw 21002

A Bylaw to amend Bylaw 7465, as amended, being the Rampart Industrial Area Structure Plan

WHEREAS pursuant to the authority granted to it by the Planning Act, the Municipal Council of the City of Edmonton, on April 24, 1984, passed Bylaw 7465, being The Rampart Industrial Area Structure Plan; and

WHEREAS Council found it desirable to amend the Rampart Industrial Area Structure through the passage of Bylaws 10351, 15456, 16627, 18580, 18843, 19572, and 20858; and

WHEREAS an application was received by Administration to further amend the Rampart Industrial Area Structure Plan, as amended; and

WHEREAS Council considers it desirable to amend the Rampart Industrial Area Structure Plan;

NOW THEREFORE after due compliance with the relevant provisions of the Municipal Government Act, S.A. 2000, c. M-26, as amended, the Municipal Council of the City of Edmonton duly assembled enacts as follows:

- 1. The Rampart Industrial Area Structure Plan, which forms part of Bylaw 7465, as amended, is hereby further amended by:
 - a. Adding a new Section IV.1(d), as follows::
 - d) Business Employment & Educational

Business Employment and Educational land uses shall be developed at Plan 8121200 Blk OT & NE-35-53-25-4, located on a combined 13.9ha site west of 142 Street NW at the intersection of 162 Avenue NW. These lands will be developed with a School as the primary use, with additional related business employment uses, including Community, Basic Service and Commercial uses. This offers a highly accessible location for a School use, near existing residential developments to the east as well as major transportation routes to accommodate students traveling from other areas of the City. Existing active transportation paths connecting the site to parks and open spaces to the south and southeast will be extended to the site to complement the development, and an existing 20m wide greenway buffers the site from existing industrial development to the south.



- d. Deleting "Figure 5 Development Concept" and substituting therefore with "Figure 5 –
 Development Concept", attached hereto as Schedule "C".
- e. Deleting "Figure 6 Mobility Network Plan" and substituting therefore with "Figure 6 Mobility Network Plan", attached hereto as Schedule "D".




