Recommended Catalyst Projects

Catalyst Project Parameters

The province has adopted guidelines for the CRL program which place limitations on what CRL funds can be used for:

- Municipal capital infrastructure within the CRL Area
- Debt financing related to improvements in the CRL Area
- Remediation of contaminated areas
- Addressing Housing needs and community design
- Area beautification to attract people and investments
- Planning requirements including consultation with Indigenous communities and analysis of broader impacts

CRL Funds are not to be used for:

- Private Property
- Operation and routine maintenance of private or municipal facilities or services

Brownfield Remediation	Several sites in the CRL area are known to be contaminated. Remediation can be a costly process that deters development. The sites within the CRL areas are eligible for the Brownfield Redevelopment Grant Program, but the grants must be funded by general revenue. Including Brownfield Remediation in the CRL would allow grants within the CRL area to be paid by their uplift in property taxes. All other restrictions of CRL funding would still apply.	New Project	\$10-15 million (estimate, 2024 dollars)
Transit Infrastructure (LRT Entrances)	Each day, thousands of people enter Downtown through the LRT entrances. These entrances are old and detract from a positive first impression of Downtown. This project would involve aesthetic and functional improvements to transit stations.	New Project	\$20-30 million (estimate, 2024 dollars)
Public Open Space Amenities and Placemaking	A program for small-scale, 'tactical' improvements to public spaces in the Downtown CRL area. Examples could include but are not limited to, small-scale recreation amenities, lighting programs, infrastructure to support events and festivals, etc.	New Project	\$15-25 million (estimate, 2024 dollars)
Downtown Infrastructure Fund	A program to fund shared public infrastructure to support new construction, including market housing, non-market housing, mixed-use, and commercial development. This would include District Energy. Program details would be developed if funding is approved, but could resemble the Infill Infrastructure Fund. Attainable Housing Incentive Program	This is an existing project where a financial incentive program for creating new attainable housing units, whether by new construction or the conversion of commercial/office space could be developed.	Amende d Scope	\$30-50 million (estimate, 2024 dollars)
