Charter Bylaw 21067

A Bylaw to amend Charter Bylaw 20000, being <u>The City Plan</u>,

WHEREAS pursuant to the authority granted to it by the Municipal Government Act, on December 7, 2020, the Municipal Council of the City of Edmonton passed Charter Bylaw 20000, being The City Plan; and

WHEREAS Administration has submitted an application to amend Charter Bylaw 20000, The City Plan; and

WHEREAS the Municipal Council of the City of Edmonton considers it desirable to amend The City Plan;

NOW THEREFORE after due compliance with the relevant provisions of the Municipal Government Act, RSA 2000, ch. M-26, as amended, the Municipal Council of the City of Edmonton duly assembled enacts as follows:

 - c. Deleting the map entitled "Map 10B Anticipated Growth from 1.25-1.5 Million" and replacing with the map entitled "Map 10B Anticipated Growth from 1.25-1.5 Million", attached hereto as Schedule "C" and forming part of this bylaw.
 - d. Deleting the map entitled "Map 10C Anticipated Growth from 1.5-1.75 Million" and replacing with the map entitled "Map 10C Anticipated Growth from 1.5-1.75 Million", attached hereto as Schedule "D" and forming part of this bylaw.


