The reduction in the number of tickets issued in 2023-2024 is attributed to two factors:

- The budget for dedicated Municipal Enforcement Officers was reduced from 15 seasonal staff for the 2022/23 season to five for the 2023/24 season.
- There was no Phase 2 (residential) parking ban in the 2023/24 season, which typically would have resulted in an increased number of tickets.
